Allen	YWCA Northeast Indiana	The proposed program seeks to empower individuals. Services provided by the sexual assault coordinator will include supervising the sexual assault advocate, along with providing services such as case management, advocacy, referral services, and support groups. The coordinator will also work as an advocate, working one-on-one with victims.	\$56,013
Delaware	A Better Way Services, Inc.	A Better Way will provide advocacy for survivors of sexual assault and human trafficking over an eight-county area. The organization will serve as a part of the Delaware County Sexual Assault Team, provide support in rural areas, operate a rape crisis center, and provide shelter as needed. Victims will have access to emotional support, counseling, support group, case management, advocacy, transportation, and other individualized services specific to their needs.	\$63,282
Dubois	Crisis Connection, Inc.	Crisis Connection, Inc. Advocacy Services team will provide comprehensive services to those impacted by sexual violence. Advocates and trained volunteers are available 24 hours a day to respond to requests for services by medical professionals, law enforcement and victims. The Advocacy Team provides a timely response to requests for crisis intervention, protective order assistance, medical/forensic/legal advocacy and accompaniment, personal advocacy and emergency and non-emergency housing.	\$54,885
Hamilton	Prevail, Inc. of Hamilton County	Prevail will provide trauma-informed, broad-based crisis and restorative support services to meet the needs of victims of sexual assault as well as their family and household members.	\$42,971
Howard	Family Service Association of Howard County, Inc.	Family Service Association Domestic Violence and Sexual Assault program will provide one full-time and one part-time Sexual Assault Advocate to provide intervention services, advocacy services and supportive services to any victim of sexual assault, as well as secondary victims or other collateral victims. Both advocates will be on-call 24/7 to respond to requests for services, and the part-time advocate will primarily provide services to the rural counties in our catchment area.	\$46,076
Jasper	North Central Indiana Rural Crisis Center, Inc.	The proposed program will ensure that a trained advocate is available to both primary and secondary victims at all times following a sexual assault. This includes having staff members available 24/7 to respond to local hospitals to provide on-site advocacy, information and referrals to sexual assault victims who seek medical attention or exams.	\$47,618

Lake	Fair Haven, Inc.	Fair Haven, Inc. will retain, enhance and strengthen sexual assault victim advocacy in Northwest Indiana by providing core services to victims/survivors of sexual assault, engage in community-based education, outreach and awareness to reach more individuals and families dealing with trauma following a sex crime and to increase services/information provided to our underserved local Hispanic/Latino community.	\$66,757
Marion	Children's Bureau	Children's Bureau (formerly Families First) requests funding to support its Sexual Assault Survivor Services (SASS) program. The SASS program includes all components of a rape crisis center by offering support, education, resources, referrals, and advocacy for survivors of sexual violence to ensure that they overcome the trauma of their experiences.	\$63,490
Vanderburgh	Albion Fellows Bacon Center, Inc.	The project will help supplement and expand sexual assault programming, direct intervention, and related assistance for victims of sexual assault.	\$57,435
