# Information on Community Services

You may receive information on community resources. This can include things like food, mental health, employment support, or affordable housing lists.

#### **Prevention**

If funds are available, you may be referred to an agency who can help you remain in your housing. You may receive case management or financial help from that agency.

To be eligible, you will need to be someone who is about to lose their home in the next two weeks, don't have another place to go, and don't have enough money or help from others to find a new place to live. You may also have to meet income criteria.

If you are connected to a resource, an agency will reach out and request info about you and your household. You may have to verify your situation by providing things like an eviction notice. You will also need your important identification documents to verify your identity.

## Interview, Prioritize & Referral

Selection for resources is based on vulnerability, eligibility requirements, and resource availability. If eligible, you could receive housing resources such as:

- Rapid Re-Housing which is short-term rent help and case management.
- **Permanent Supportive Housing** which is long-term rent help with ongoing case management. To be eligible, a household would have meet the above criteria for a long period of time and have a disability.

#### To be eligible, you need to be one of the following:

- sleeping in a place that's not really meant for people to live in (like a car or a park)
- staying in a shelter that's only meant to be a temporary place to live
- trying to leave or recently left a space where you are not safe because someone is hurting you or threatening to hurt you and you don't have another place to go and don't have enough money or help from others to find a new, safe place to live.

You may also have to meet income criteria.

If you are connected to a resource, an agency will reach out and request info about you and your household. You may have to have provide information that confirms you are experiencing homelessness. You will also need your important identification documents to verify your identity.
