1st. Platoon: Robbery reduction along Preston and Poplar Level Corridors (Hotels, Thorntons and Speedway) – trespassing in Camp Taylor Park and GRCP – homeless around Preston/Eastern and around Post Office – Burg- 4239 Illinois Ave @ the Congregation of Jehovah's Witnesses-suspect forced the metal garage door with a possibly vehicle gaining entry. Suspect took * Gas Trimmers and a Gas Back Pack Blower. Burg-1100 Trevilian Way @ (Louisville Zoo)- suspect cut the lock off of a storage container to gain access, once inside suspect took *40 Heavy Duty Extension Cords. No suspect at this time.

1st. **Platoon:** Robbery reduction along Poplar Level and emphasis on open air drug markets and economic hotels.

Burg -2100 block of Goldsmith Ln- suspect enter through the back window and took two Cameras. Burg-2007 block of Terril Ln victim states that her apt door was forced open. Suspect entered and removed a *Tablet with a 7" screen. Burg-101 Trafalgar Sq- suspect forced open the victim's apt door, once inside the suspect removed * Nintendo WII, 32" Flat Screen TV, and jewelry. Burg-5600 block of Ailanthus Trl-suspect forced open a shed in the victim's back yard and removed * a lawn mower.

2nd Platoon: Robbery reduction along Poplar Level and emphasis on open air drug markets and economic hotels –Burg-3400 block of Pemaquid Rd- suspect gained entry into residence through a rear door and took *Misc women jewelry and perfume. <u>All Shifts</u> There were no major offences on this beat that can clearly be linked to a specific shift. Two Burglaries could have occurred on 2nd or 3rd Platoon

Burg-2000 block of Landing- Victim stated that when he returned from the hospital he discovered that his apartment had been broken into and that the listed items were missing *a Play Station, Cash, a 55" Flat Screen TV and a 32" Flat Screen TV. <u>All Shifts</u> Most offences occurring on this beat can't be clearly linked to one specific shift. Most offences occurred during a wide time frame covered by more than one shift.

We have also recently heard concerns about the Hikes Lane corridor (Mid Dale, Orchard Manner, Clingstone, and White Hall).
