Free Storm Debris Drop-Off

Thursday, June 28 - Saturday, July 7 Metro Waste Reduction Center (636 Meriwether Avenue)

The Metro Waste Reduction Center, 636 Meriwether Avenue, will accept drop-off of residential storm debris from Thursday, June 28 through Saturday, July 7. Eligible debris includes tree limbs and other compostable materials. No construction or demolition materials, shingles, municipal garbage or manmade materials will be accepted.

The free service is available to Jefferson County residents only. **Contractors or persons for hire must pay according to the posted fee schedule.** They are not included in the free service.

To qualify for the free drop-off residents must present the attendant government issued identification verifying Jefferson County residency. Storm debris will be accepted at the Waste Reduction Center Tuesday through Friday between the hours of 8 a.m. and 5 p.m., and Saturday 8 a.m. to 3 p.m.



Get Your Vegetables from the New Roots Fresh Stop Market!

The Fresh Stop Markets (FSM) are run by leaders in a grassroots food justice movement that operates from the belief that fresh food is a basic human right. FSMs are volunteer, community-driven farm-fresh food markets that pop up bi-weekly at local churches and community centers in neighborhoods that do not have grocery stores or farmers' markets. Shareholders ("customers") agree to cooperate and pay ahead of time, on an income-based sliding scale. The sliding scale means food is affordable and everyone is included.

WIC participants pay \$6, those at or below 185 percent federal poverty guidelines pay \$12, others pay \$25, and those who would like to invest in the community pay \$40. SNAP IS ACCEPTED. Everyone gets the same food!

PetSmart Charities Awards LMAS \$40K Grant

Funding aimed at reducing pet population through local spay/neuter efforts

Louisville Metro Animal Services recently received a \$40K grant from PetSmart Charities, the leading funder of animal welfare in North America, to help reduce the pet population in Jefferson County. LMAS is using the grant to offer spay/neuter vouchers to Jefferson County residents, which can be redeemed at any Jefferson County Veterinary office or the Kentucky Humane Society SNIP Clinic.

By offering assistance for discounted spay/neuter surgeries, LMAS will increase in-house surgeries (2,700 in 2017) and those performed by outside providers. The voucher not only encourages responsible pet ownership, it helps reduce uncontrolled breeding of stray cats and dogs and allows LMAS to be proactive about future shelter overcrowding.

The voucher covers up to \$100 of the cost to spay/neuter a cat or a dog. Vouchers can be obtained at the LMAS Animal Care Center located at 3705 Manslick Rd. Monday-Friday between 12-6pm, or Saturdays 11-2pm; or at Animal House Adoption Center located at 3516 Newburg Rd. Tuesday-Sunday from 12-6pm. The Office of Safe and Healthy Neighborhoods is now a stand-alone department with \$3.6 million to continue to support youth development and community outreach. This includes \$892,600 for sites 1 and 2 of the No More Red Dots Violence Reduction Program, \$446,200 for site 3 at UofL Hospital and Peace Education and Site 4 at the YMCA, and also includes funding for:

Urban League Expungement Program - \$15,000 Board 4 Change / Little Hands Little Feet - \$15,000 Urban League Housing Rehabilitation (Jesus and a Job) - \$60,000

Within six months of the establishment of the first Cure Violence site, but no later than **March 31, 2019**, the Director of the Office for Safe and Healthy Neighborhoods is requested to provide the Metro Council's Public Safety

Committee a report for each focus area to include, but not limited to, reductions in shootings, reductions in homicides, number of neighborhood canvasses and outcomes, number of neighborhood events and outcomes and number of connections made between outreach workers and participants for community services such as drug treatment, GED, mentoring and job training. After the first report, quarterly reporting to the Metro Council is required.

An alley retaining wall will be reconstructed on Southwestern Parkway at \$41,900 as part of the infrastructure updates.

New sidewalks will be constructed on the west side of South 45th Street in the 900-1000 blocks from Garland Avenue to Greenwood Avenue at \$90,000.

The budget also maintains other recommended funding for paving, sidewalk repair, and construction as outlined in the 3 Year Paving Plan presented as part of the FY18-19 capital budget and agreed upon by each council member for **metro street paving**.

Metro Sidewalk Repair Program includes sufficient funding to repair all sidewalks rated a 4 or 5 reported through May 1, 2017. Included in the funding is a minimum of \$25,000 per district for reported 4s and 5s approved by the council member.

The Alley Improvement Match Project requires an equal match from district funds. A maximum of \$10,000 per alley may be drawn from the account.

Main Library—No later than September 30, 2018 the Director of the Louisville Free Public Library is requested to submit a plan renovation for the renovation of the Main Library including but not limited to, utilization of space, personnel needs and new programs/ services provided as well as any program/ service proposed to be discontinued or reduced.

The Heritage West Project / "Track on Ali" is estimated to cost \$30 million. Metro is committing the land and a \$10,000,000 bond to the project in addition to the \$350,000 already committed for infrastructure improvements.

The Louisville Affordable Housing Trust Fund is fully funded again this year at \$10,000,000.

Volunteers of America Elevator Repair/Replacement Project at the Volunteers of America Freedom House location at 1436 Shelby Street will be up \$100,000.

City and Urban League Sign Development Agreement for \$30 Million Redevelopment of Heritage West

Mayor Greg Fischer joined Sadiqa Reynolds, President and CEO of Louisville Urban League, and community leaders to announce that Louisville Metro Government (LMG) has entered into a development agreement with the Louisville Urban League (LUL) for the redevelopment of the Heritage West site, a 24-acre property in the Russell neighborhood. LUL's master plan is centered on a 4,000-seat indoor and outdoor track and field facility and will feature community green space and outdoor event space. The development agreement states that, pending Metro Council approval, LMG will provide \$10 million toward construction costs of the track. Construction is expected to begin in early 2019. "There is no silver bullet in community revitalization and while sports may be part of an answer, track is not now, nor has it ever been the entire answer. While we can't ignore the cries of our local track teams to 'build this facility,' this project is about more than sports. It is about economic opportunity, families traveling into our community with disposable income and the jobs and organic growth that will happen as a result of this catalytic project. It is truly about the need for a facility like this in our community and since it is to be built, why not right here in Russell," said Sadiqa Reynolds, President and CEO of Louisville Urban League. "I am thrilled about the work we are about to do and the support this project has garnered, not just from the local community but from partners like the National Development Council (NDC), a national not-for-profit economic development agency that has been working to increase the flow of private capital into underserved areas for almost fifty years."

The complex will be designed to host a variety of gional public sporting events supported by organizations such as USA Track and Field, and the NCAA, our local and regional public and private

schools and local track teams. The facility also will feature retail space and related amenities and will be owned and operated by the LUL. Browne Engineering & Construction has been selected as the Project Manager and Moody Nolan has been selected as the architect. "NDC is delighted to have the opportunity to be working with the Louisville Urban League and its first rate committee on this mixed-use recreation facility that will be a catalyst for future development opportunities and lead to a substantial community impact in the Russell neighborhood for years to come," said Kevin Gremse, Senior Director of National Development Council. Heritage West is located on the western border of the Russell neighborhood, which is currently seeing an influx of investment, including the \$29.5 million mixed-income, mixed-use redevelopment of Beecher Terrace, a project expected to leverage at least \$200 million in new investment; Waterfront Park Phase Four expansion; relocation of Passport Health Plan's headquarters; construction of a new YMCA at 18th and Broadway; and the city's first Bus Rapid Transit Line. "I am excited that this project is continuing to move forward with a \$10 million commitment, pending Metro Council approval, from Louisville Metro Government to help make this dream a reality. The west Louisville community participated in discussions and sessions to make this sports complex project a priority for our community, and it will certainly be a destination spot for Louisvillians and visitors to the city alike," said Councilwoman Cheri Bryant **Hamilton, D-5**. "This project will help change a 24acre vacant lot into a positive vision of hope and a productive use which will generate other positive effects for our neighborhood. Thank you to Sadiqa Reynolds and everyone at the Louisville Urban Louisville for their belief and dedication to this project, and let's do all we can to help make this dream a reality." In the evaluations panel Bonnie Cole, Bill Gatewood, Vanessa Lackey and Gary Watrous represented the community and Jeana Dunlap (Director of Redevelopment Strategies), Laura Grabowski (Director of Vacant and Public Property Administration), **Scott Herrmann** (Director of Economic Development), Aaron Jackson (Director of Finance) and Allison Smith (Brownsfields Program Manager) represented LMG.
