Programs Offered to Kentucky Veterans Pre 9/11

Resources

After every case is reviewed, they are offered national and local resources if they do not comply with our guidelines.

Emergency Assistance

1. Ineligible discharges: Other Than Honorable, Dishonorable, or Uncharacterized
2. Hardships due to circumstances beyond personal control that caused loss of income in past 12 months
3. Required to be resident of Kentucky

Assistance reviewed for:

1. Utilities
2. Auto (loan, insurance, repairs)
3. Emergency Food
4. Medical Expenses not covered by VA
5. Moving Expense to obtain employment
6. Funeral or Burial Expenses for Veteran, including travel (for immediate family member)

Housing Assistance

1. Ineligible discharges: Other than Honorable, Dishonorable, or Uncharacterized
2. Hardship due to circumstances beyond personal control that caused a loss of income in the past 12 months
3. Required to be a resident of KY

Assistance reviewed for:

1. Emergency Lodging (only if Homeless)
2. Rent
3. Mortgage
4. Rental Deposit/First Months rent

HVRP

1. Ineligible Discharge: Dishonorable
2. At Risk for Homelessness
3. Homeless within the past 60 days
4. Transitioned from incarceration within the past 12 months
AND Income-Based Reviewed Based on ZIP CODE/ KY Resident only

Assistance reviewed for:

1. Bus Transit Passes or Fuel Cards
2. Employment Security (daycare, tools, uniforms, license)
3. Housing Referrals
4. Advocate/Connect with local employers
5. Resume and Interview assistance

Programs Offered to Kentucky Veterans Post 9/11 & current military

**** National Programs (outside of KY), have different guidelines and offer separate types of assistance**

****Emergency Assistance**

- 1. Ineligible Discharges: Other Than Honorable, Dishonorable, or Uncharacterized**
- 2. If Serving, copy of LES**
- 3. KY Veterans Only - Hardships due to circumstances beyond personal control that caused loss of income in past 12 months**

Assistance reviewed for:

- 1. Utilities**
- 2. Auto (loan, insurance, repairs)**
- 3. Emergency Food**
- 4. Medical Expenses not covered by VA**
- 5. Moving Expense to obtain employment**
- 6. Funeral or Burial Expenses for Veteran, including travel (for immediate family member)**

****Housing Assistance**

- 1. Ineligible Discharges: Other Than Honorable, Dishonorable, or Uncharacterized**
- 2. If Serving, Copy of LES**
- 3. KY Veterans Only - Hardships due to circumstances beyond personal control that caused loss of income in past 12 months**

Assistance reviewed for:

- 1. Emergency Lodging (only if homeless)**
- 2. Rent**
- 3. Mortgage**
- 4. Rental Deposit/First Months Rent**

HVRP

- 1. Ineligible Discharges: Dishonorable**
- 2. At Risk for Homelessness**
- 3. Homeless within the past 60 days**
- 4. Transitioned from incarceration within the past 12 months
AND Income-Based Reviewed Based on ZIP CODE/KY Resident only**

- 1. Bus Transit Passes or Fuel Cards**
- 2. Employment Security (daycare, tools, uniforms, license)**
- 3. Housing Referrals**
- 4. Advocate /Connect with local employers**

Programs Offered to Kentucky Veterans

Post 9/11 & current military

****** Program is offered to cut the financial barriers from unemployed veterans/military/spouses to obtain successful employment

****Career Transition Financial Assistance**

1. Ineligible Discharges: Other Than Honorable, Dishonorable, or Uncharacterized

2. If Serving, copy of LES

- 1. Assists unemployed service members, military spouses, or veterans who have experienced a gap of income for 30days+**
- 2. Assists with temporary grant assistance if they have received a firm job offer with a start date w/in the next 30days**
- 3. Provides assistance if they have not received their first full paycheck**
- 4. Cannot review jobs that are: part-time, contingent offers, temporary, or commission based**
- 5. Offers assistance with past due bills, daycare, moving expenses, clothing for employment**

Career Transition Employment Assistance

Provides individuals with tools and resources to better prepare them for the hiring processing and refers qualified candidates to corporate organizations with open positions, specific to their skill set.
