

TRANSPORTATION ALTERNATIVE PROGRAM (TAP) AWARDS FEDERAL DOLLARS AWARDED

Anderson County, City of Lawrenceburg – **Downtown Lawrenceburg Sidewalk Replacement Project**, \$432,000 – Replacing dilapidated sidewalks of various widths, to ADA compliance and storm water management.

Allen County, City of Scottsville – **Heart of Scottsville/Streetscape Project**, \$577,124 - Final block of the "Heart of Scottsville" Streetscape Project. Reconstruction of sidewalks to ADA compliance, improved lighting and bump-outs to improve vehicular sight distance for overall safety.

Bath County, City of Owingsville – **Owingsville Sidewalk upgrade and Extension Project**, \$27,200 – Upgrade sidewalks to ADA compliance and add a new sidewalk for additional connections, i.e. Bath Co. High School and Owingsville Elementary.

Boone County, City of Boone CFC – **Burlington Multi-Use Path Project**, \$1,164,836 – The addition of 10' multi-use path. Connecting residents to retail businesses and other local entities.

Bullitt County, City of Mt. Washington – **Mt. Washington Historic Memorial Multi-Use Trail (Segment C)**, \$500,000 – Continuation of a larger trail through town, creating a non-driver system. Connecting residents to parks, schools, neighborhoods, city pool, etc.

Calloway County, City of Murray – **US-641 (N. 12th Street) Sidewalk Improvement Project**, \$799,985 – New sidewalk connecting other sidewalks; Murray State University, commercial businesses and transit stops.

Campbell County, City of Silver Grove – **Silver Grove KY-8 Sidewalk Project** (Section 2), \$178,417 – Replacing noncompliant 5' sidewalks along south side of KY-8. Includes upgrade to ADA compliance, drainage improvements and crosswalk striping.

Campbell County, City of Fort Thomas – **North Fort Thomas Avenue Sidewalk Project**, \$596,640 – Sidewalk will serve schools and neighborhood for health and ADA compliance.

Christian County, City of Hopkinsville – **Hopkinsville Greenway System (Section 2),** \$716,000 – Extend trail along rail bed. Continuation of previous project.

Crittenden County, City of Marion – **Marion Sidewalk Project**, \$154,560 – New and upgraded sidewalks to serve downtown area.

Grant County, City of Dry Ridge – **Warsaw Road Sidewalk**, \$256,000 – New sidewalk connection serving multiple areas including the Grant County High School and Technical Campus.

Graves County, City of Mayfield – **Mayfield Bikeway**, \$506,000 – Installation of 8' paved shared-use paths connecting several parks and senior center.

Green County, City of Greensburg – **Greensburg Greenway Belt,** \$277,257 – New Sidewalks on Old and West Hodgenville Road to connect Hillview neighborhood to downtown.

Hancock County, City of Hawesville – **Hancock Fiscal Court, Hancock County Museum**, \$149,620, Restoration of a Historic Railroad Station building in Hawesville.

Hopkins County, City of Morton's Gap – **Morton's Gap Sidewalk Project**, \$ 102,400 – New sidewalks. To be ADA compliant and eliminate the safety concern of citizens walking in the roadway.

Jackson County, City of McKee – **McKee Sidewalk Project**, \$250,470 – New ped-bridge and sidewalks creating connectivity between downtown, schools and parks.

Jefferson County, City of Middletown – **South Madison Avenue Sidewalks**, \$328,400 – Sidewalk installation from Main St. to S Madison St., upgrading to ADA compliant.

Johnson County, City of Paintsville – **Paintsville Sidewalk Improvements (Section 2),** \$400,000 – Rehabilitation of sidewalks.

Kenton County, City of Covington – **Riverfront Commons Highway Avenue Connection**, \$880,000. Walk/bike path making additional connection West of Brent Spence to Hwy Avenue.

Kenton County, Crescent Springs and Villa Hills – **Amsterdam Road Sidewalk Connector Project**, \$705,229 – Installation of 5' sidewalk nearly one (1) mile, making multiple connections for neighborhoods, schools and commercial businesses.

Laurel County, City of London – **South Mill Street Sidewalk Project**, \$409,482 – New sidewalk. Priority connection for the city's Bike/Ped Master Plan.

Laurel County, City of London – **West Dixie Street Sidewalk**, \$37,350 – New sidewalk. Priority connection for the city's Bike/Ped Master Plan.

Meade County, City of Brandenburg – **Brandenburg Downtown Highway Restoration Project**, \$222,240 – Sidewalk connecting downtown, River Park and several other existing sidewalk systems.

Montgomery County, City of Jeffersonville – **Jeffersonville Sidewalk Extension**, \$121,813 – New sidewalk connecting existing system with City Hall and park area.

Montgomery County, City of Mt. Sterling – **Mount Sterling Transportation and Revitalization Project**, \$650,000 – Update of existing downtown pedestrian facilities and new sidewalks to connect multiple areas.

Nelson County, City of Bardstown – **John Rowan Boulevard and Connecting Multi-Use Path,** \$552,000 – Nearly two (2) miles of extended multi-use path that will connect a previously built path.

Lawrence County, City of Louisa – **Rediscover Louisa Riverwalk**, \$312,200 – Multi-use path along the river with several connections, including the existing sidewalk system near the bridge.

Pulaski County, City of Burnside – Burnside Sidewalk Project, \$73,113 – New and upgraded sidewalks to ADA compliant.

Scott County, City of Stamping Ground – **Main Street Sidewalks**, \$123,040 – Sidewalks in town, providing a safer commute for handicap residents and those living in a low income housing area.

Scott County, City of Georgetown – **W. Main Street (US-460) Roadway and Sidewalk Improvements,** \$600,000 – Main Street Sidewalks and Street Rehab, to provide safer commute for pedestrians to local businesses.

Taylor County, City of Campbellsville – **Old Lebanon Road Sidewalk Project**, \$113,618 – New sidewalk connecting greenway with medical office park.

Todd County, City of Guthrie – **Guthrie Sidewalk Project**, \$180,000 – New sidewalks for underserviced area to the downtown and recreation sections of town.

Warren County, City of Woodburn – **Woodburn KY-240 Pedestrian Improvements**, \$134,552 – New sidewalk provides a connection between an existing sidewalk and Main Street.

Warren County, City of Bowling Green – **West End Greenways Connector and Intersection Improvements,** \$500,000 – Closes the gap between the Greenways network and downtown.

CONGESTION, MITIGATION AND AIR QUALITY (CMAQ) AWARDS FEDERAL DOLLARS AWARDED

Replacement Buses for Boone, Kenton and Campbell County. \$2,095,680.00 - Funds to purchase four hybrid electric diesel fixed-route buses to replace four diesel buses.

Boone County – **Limaburg Intersection Improvements**, \$281,970.36 - This project will redefine the southbound lanes of Limaburg Road on the north side of the KY-18 intersection, allowing for an expansion of the number of vehicles that can be accommodated in the dedicated left-hand turn lane. The project will include extending the dedicated left turn lane, a straight/left turn lane and a dedicated right turn lane.

Boone County – **Burlington Bus Service**, \$57,731.11 - Extension of bus service to the county seat in Burlington. The proposed route is 6.3 miles in length and connects low income residents to many social service agencies.

Davies County – **Rail Track Expansion**, \$1,160,453.60 - Extension of rail track infrastructure within the Riverport authority for dedicated business within six miles of the port authority. This will deliver one truck per hour for 13 hours to the Owensboro Riverport for outbound rail.

Fayette County – **Armstrong Mill Sidewalks**, \$1,062,720 - Construction of sidewalks on the North and South side of Armstrong Mill Road from the intersection with Tates Creek Road to the intersection with Greentree Road and then on to the intersection with the Armstrong Mills side roads. This will also include three prefabricated structures to cross the Lansdowne Drive tributary and West Hickman Creek. A new traffic signal will also be installed at the intersection of Greendale Road and Armstrong Mill for pedestrian Crossing.

Fayette County – **Mercer at Greendale**, \$793,840 – Widening of both sides of Mercer Road along the westbound approach to the Greendale Road intersection to provide separate lanes for left, right and through traffic. This will also include sidewalks and bike lanes and modification of signals to support the lane use change.

Jefferson County – **Louisville Loop**, \$300,000 – Provides additional funds to complete the construction phase of an existing CMAQ funded project, the northeast Louisville Loop Middletown Eastwood Trail along US-60.

Jefferson County – **Riverport Circulator**, \$2,544,000.00 - Funding to create a new circulator route to increase the number of trips to the Riverport employment center and southwest Jefferson County.

Oldham County – **KY-53 / I-71**, \$2,593,688.98 - Reconfiguration of the I-71 southbound ramp on KY-53 to allow for two 'right turn only' lanes and one 'left turn only' lane. Additionally a left turn will be added to KY-53 at Crystal Drive.

Scott County – **Cardinal Drive**, \$1,003,200 – Reconfiguration of KY-32 to include left and right auxiliary turn lanes at Cardinal Drive and widen the rural roadway section on Cardinal Drive adjacent to the middle and HS entrances. A traffic study to be completed reviewing both one-way and two-way traffic configurations through the corridor.
