**EXECUTIVE ORDER**  
**LC-23-01**

**VIOLENT CRIME REDUCTION TASKFORCE**

**WHEREAS**, the City of New Orleans experienced 265 homicides in 2022, which was also the leading cause of death in children; and

**WHEREAS**, in 2022 major cities across the nation experienced an increase in violent crime and a reduction in available law enforcement officers; and

**WHEREAS**, as an international and world-class destination, the City of New Orleans must use every available resource across all levels of government to curb the frequency of incidents of violence; and

**WHEREAS**, 2023 has been met with a significant increase in violent crime deaths over prior years and must be treated as a public health emergency; and

**WHEREAS**, government must take a comprehensive, holistic, and urgent approach to adequately prevent and respond to acts of violence;

**NOW, THEREFORE, I, LATOYA CANTRELL**, by the authority vested in me as Mayor of City of New Orleans, by the Constitution and laws of the State of Louisiana, and the Home Rule Charter of the City of New Orleans, **HEREBY ORDER AS FOLLOWS**:

1. Effective Date

This Executive Order is effective upon the date of its issuance.

2. Purpose

The purpose of this Executive Order is the creation of the Violent Crime Reduction Taskforce led by the Executive Director of the Orleans Parish Communication District.

3. Membership


4. Task Force Authority

The violent crime reduction task force shall be responsible for developing strategies coordinated amongst all government and community stakeholders for the prevention of violent crime, the apprehension of violent offenders, and ensure comprehensive wrap-around services provided to those impacted by incidents of violence. The task force will brief the Mayor and city leaders on actions taken by the task force as well as present recommendations for changes to policy, legislation, and other actions to be taken by governmental entities at both the local, state, and federal level. The task force shall ensure members of the New Orleans City Council are engaged regularly and provide public updates as necessary.

5. Duration

This executive order shall remain in effect until amended or suspended by a subsequent order approved in accordance with Section 4-206 (3)(c) of the Charter.
