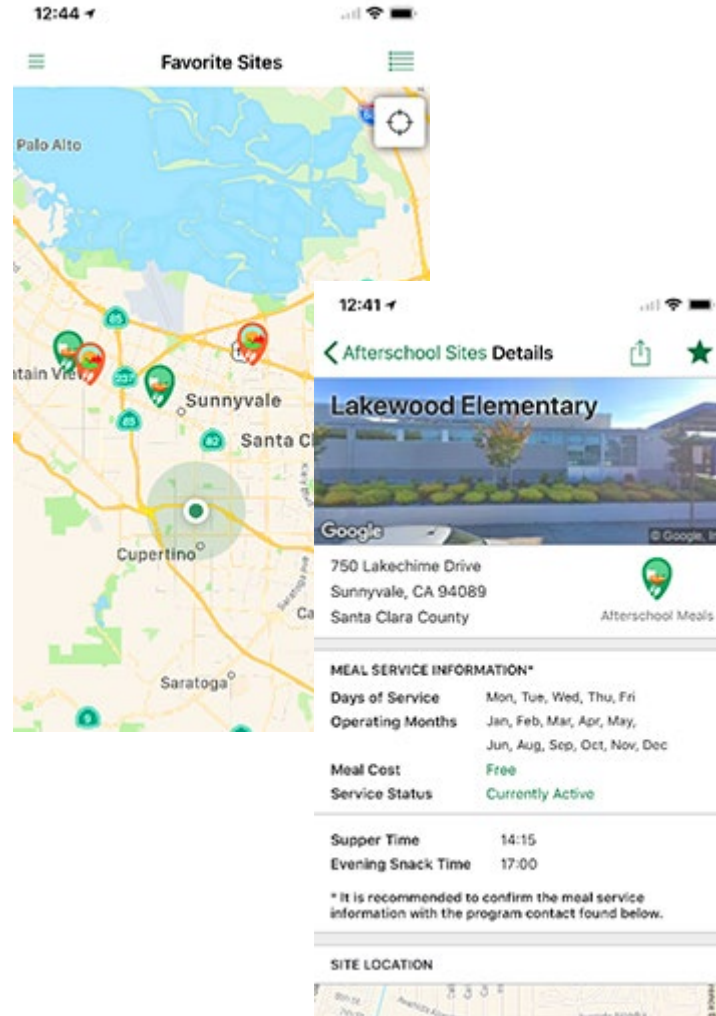

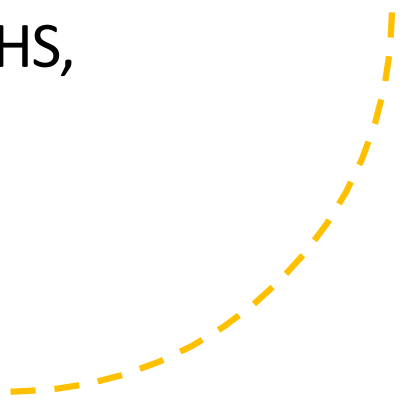

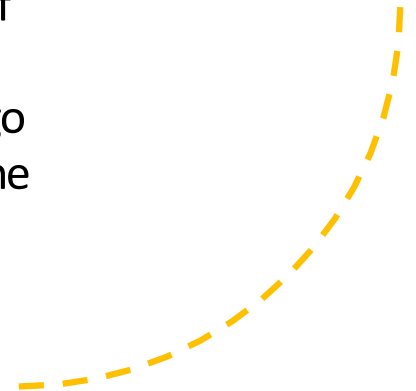

The Vast Majority of Kids Are NOT Using Drugs

- In San Diego County, **14.25%** of youth ages 12 to 17 report having used *drugs or alcohol* in the prior month.
- Grade 7: **4%** [96% don't use]
- Grade 9: **9%** [91% don't use]
- Grade 11: **16%** [84% don't use]
- Non-Trad: **28%** [72% don't use]

Adverse Childhood Experiences (ACEs)

- ACEs are potentially traumatic events that occur in childhood (0-17 years).
- People have physical injuries and sometimes they have emotional injuries.
- This can cause people to use drugs sometimes, due to the environment they live in.
- Resources can include therapy, talking to parents and friends, counselors at school
- ACEs can be prevented and treated!

What Is Addiction?

- Addiction is a complex condition, a brain disease that is manifested by compulsive substance use despite harmful consequences.
- People with addiction (severe substance use disorder) have an intense focus on using a certain substance(s), such as alcohol or drugs, to the point that it takes over their life.
- **They keep using alcohol or a drug even when they know it will cause problems.**
- Yet a number of effective treatments are available, and people can recover from addiction and lead normal, productive lives.

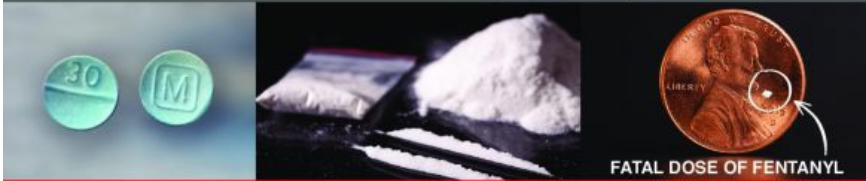

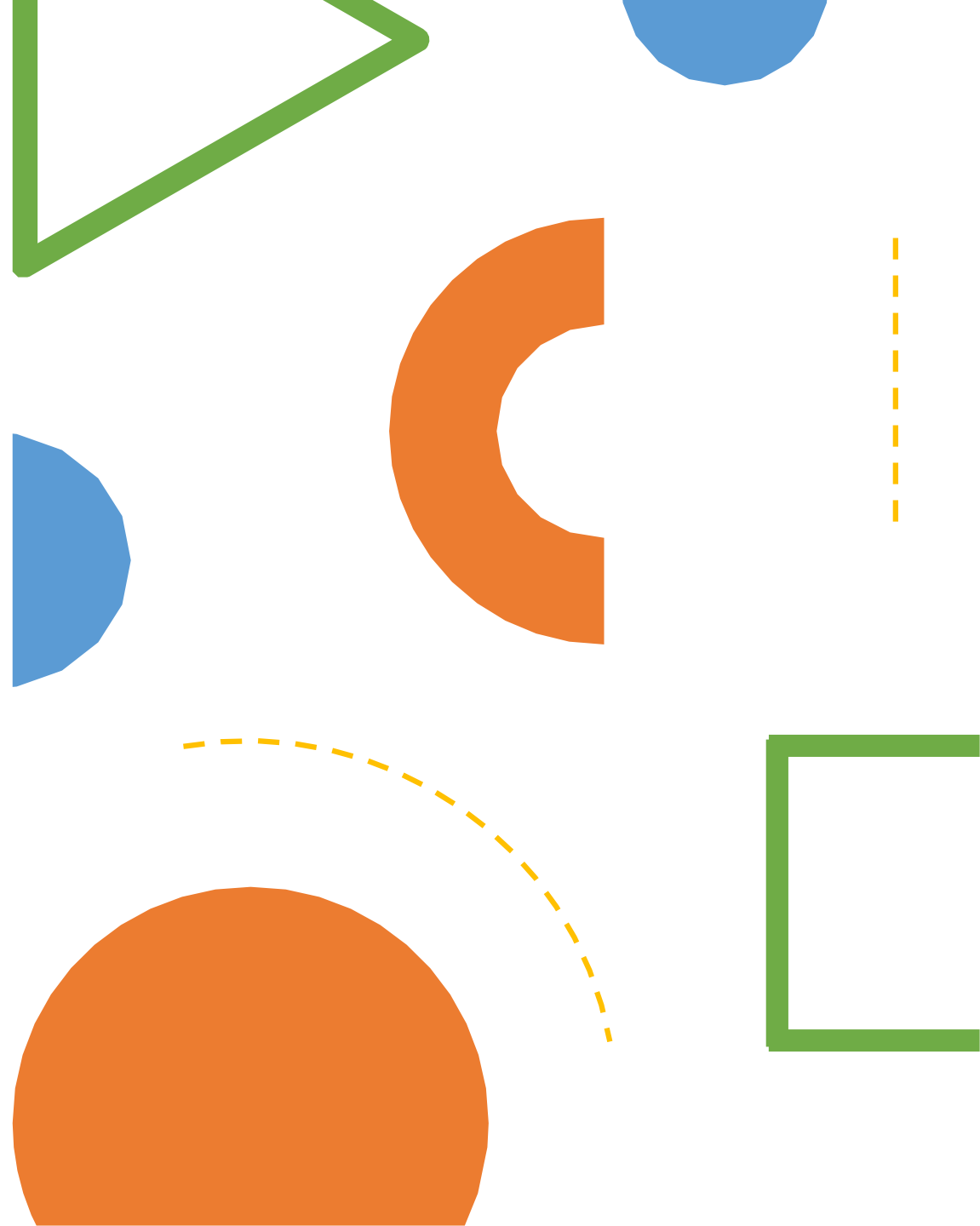

What are Opioids?

The group of drugs called opioids includes:

- ❖ Heroin
- ❖ Morphine
- ❖ Codeine
- ❖ Oxycodone
- ❖ Other prescription pain killers ie.)
Vicodin or Percocet
- ❖ Fentanyl (synthetic)
- ❖ Carfentanil (synthetic)

(Not benzodiazepines)



What is Fentanyl?

- Extremely powerful narcotic / pain medication
- Pharmacy and Hospital Use
 - Used in surgical procedures to induce anesthesia
- Opioid that is 100 times stronger than morphine
- 30 to 50 times stronger than heroin
- Used for Severe Pain – Schedule II Narcotic
- High Risk for Dependency / Addiction
- **Increasingly found in illicit drug supply**
 - **Odorless and tasteless**
 - **Many do not know it has been added to the illicit drug(s) they are using**

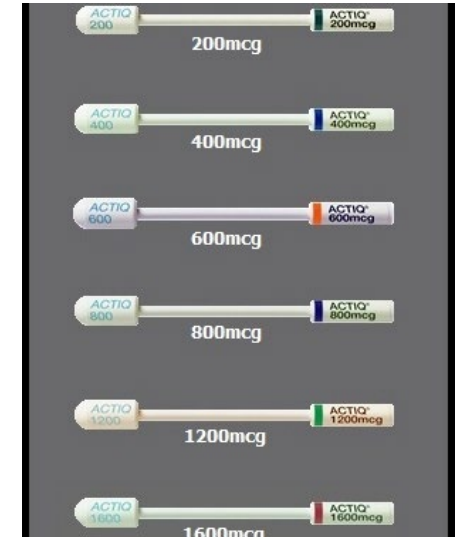
Legitimate Use by Pharmaceutical Industry

- Pharmacy and Hospital Use

Illicit Manufacturing and Use by Mexican transnational criminal organizations

- Foreign Countries supply precursor chemicals
- China and India
- Criminal organizations Manufacture Fentanyl and smuggle it into the USA
- Majority of fentanyl is smuggled through California, then moved throughout the USA

Forms of Fentanyl



Fentanyl: It doesn't take much

- As little as **2mg** of fentanyl can cause an overdose and death in an otherwise healthy adult.
- A recent DEA laboratory study found that of the **counterfeit pills** that contained fentanyl, **5 out of 10 contained a potentially fatal dose.**
- Over **50 million** counterfeit pills were seized in the U.S. in 2022.



Fatal Doses Heroin, Fentanyl & Carfentanil



As little as 2 Milligrams of Fentanyl Can Cause An Overdose and Death in an Otherwise Healthy Adult



- 2.83 Grams = 2,830 Milligrams (mg) in one sugar packet.
- 2.83 Grams of Fentanyl could be enough to cause an overdose and death for **1,415 Adults!**
- Less than 2mg for an overdose and death in Children, Toddlers, and Babies...



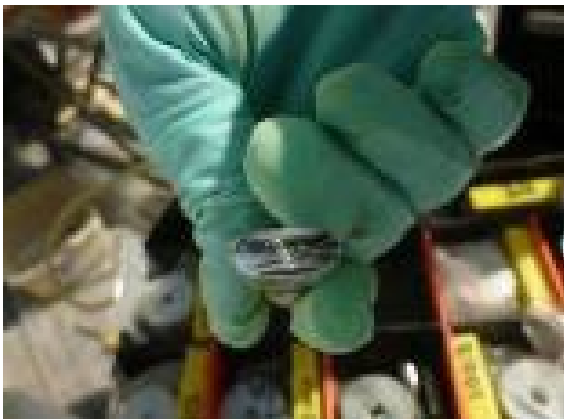

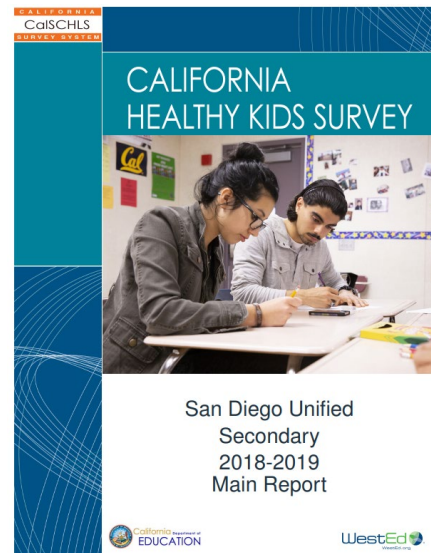

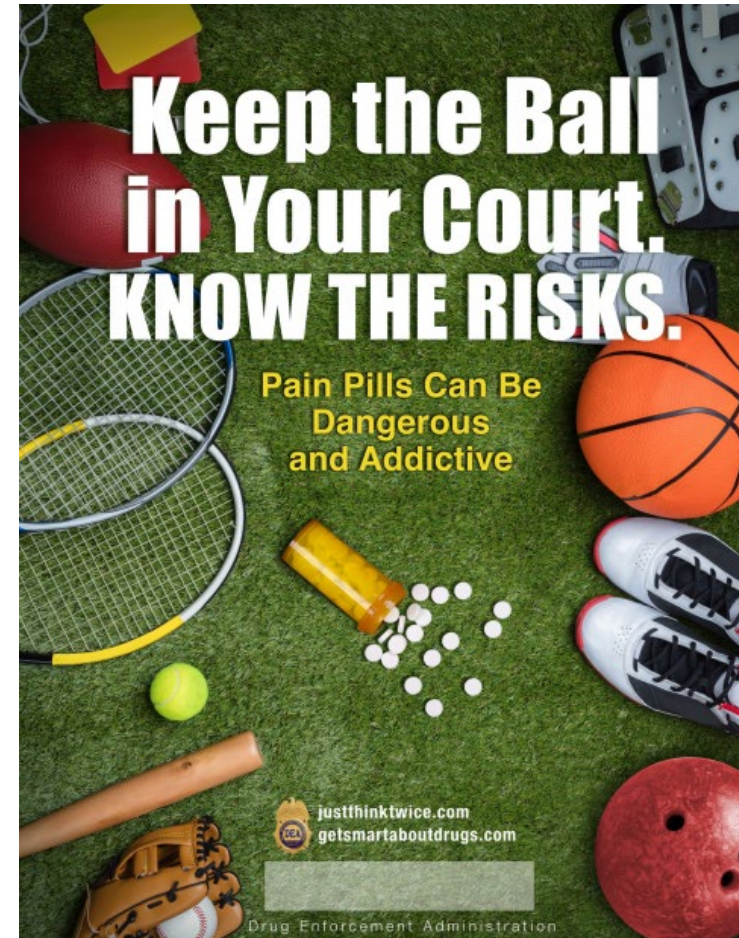

Teen girl dead from fentanyl-laced pills at Hollywood school is latest in rash of student overdoses



Students make their way to Los Angeles' Helen Bernstein School, where a 15-year-old girl was found dead after an apparent fentanyl overdose. (Mel Melcon / Los Angeles Times)

A teenage girl who died Tuesday night from an apparent fentanyl overdose at Bernstein High School in Hollywood and three other students who were hospitalized were the latest in a rash of student overdoses stemming from drugs being sold at a nearby park, according to officials.

Six students, not including the four from Tuesday night, have overdosed in the last three weeks from drugs obtained at Lexington Park, located just a few blocks from Bernstein, according to Los Angeles Unified School District Supt. Alberto Carvalho.

Carvalho met with the parents of the deceased girl Wednesday morning and confirmed that two of the four girls who overdosed, including the one who died, are 15-year-olds from Bernstein. The third girl was a 17-year-old from Hollywood High School and Carvalho didn't have information on the fourth victim.

Melanie's Law

California Education Code 32282

- **Pupil health: opioid overdose prevention and treatment: Melanie's Law.**
- This law requires a comprehensive school safety plan, and the school safety plan of a charter school, for a school serving pupils in any of grades 7 to 12, inclusive, to include the development of a protocol in the event a pupil is suffering or is reasonably believed to be suffering from an opioid overdose. By creating new duties for local educational agencies, the bill would impose a state-mandated local program.

- Effective January 01, 2024.

Prevention – One Pill Can Kill!

- **Avoid taking prescription medications, unless prescribed for you and you know the source is from an actual pharmacy.**
- You need to pick up the prescription, so you know the medication is from a legitimate, licensed pharmacy.
- Be careful with online pharmacies – make sure they are legitimate, licensed pharmacies.
- **Do not take pills from anyone else!** You don't know the true source of the pills. Did they come from a drug dealer? There is no way to tell!
- **Take medication only as prescribed!**

Prescription Drug Abuse Prevention

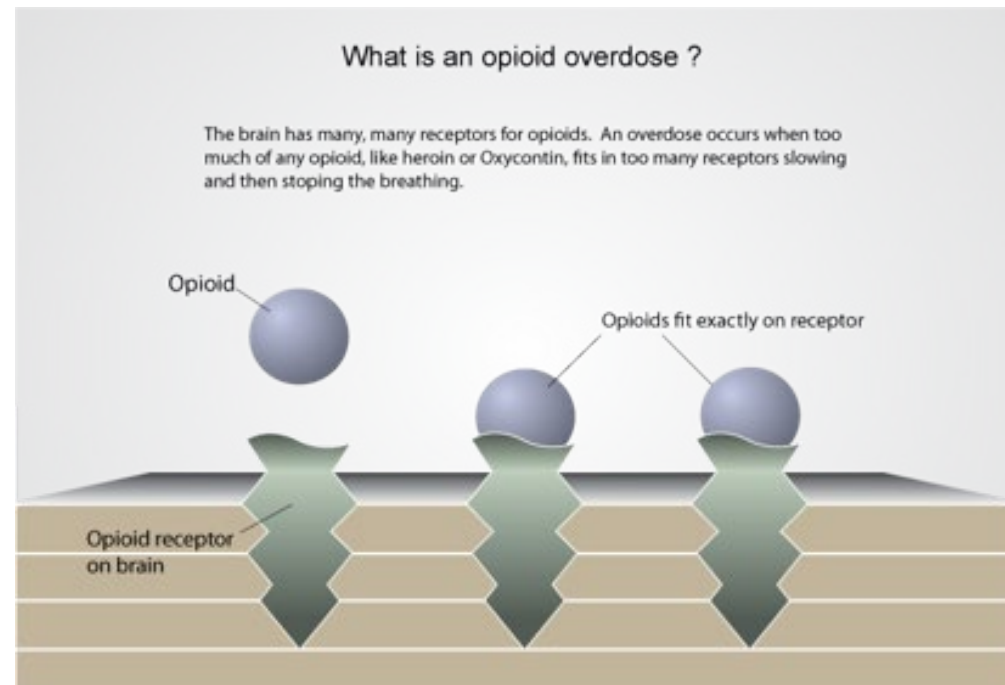
- Monitor
- Secure
- **Don't Share with others**
- Safe Disposal of Unused and/or Expired Medications
- **DEA Take Back Days**
- Don't Flush Medications Down The Toilet or Throw Into Trash
 - This avoids contamination of water and soil



Opioid Overdoses

What is an Opioid Overdose?

- The brain has many receptors for opioids
- Too much of an opioid fitting in too many receptors slow and stop breathing



Opioid Overdose Signs



Not Responding

Doesn't move and can't be woken.



Slow or Not Breathing

A breath every 5 seconds is normal.



Making Sounds

Choking, gurgling sounds or snoring



Blue Lips & Nails



Cold or Clammy Skin



Tiny Pupils

Know what to do if someone overdoses

 1 Call 911 Don't stress about calling. The Good Samaritan Law can keep you and the person overdosing out of legal trouble. Good Samaritan Law 	 2 Give them naloxone Place the nozzle in their nose and press the plunger. Wait 2–3 minutes. Repeat in the other nostril if they don't wake up. Learn how 	 3 Start hands-only CPR* Push hard and fast in the middle of their chest. The emergency dispatcher can give you CPR instructions if you need them. *Perform rescue breathing if you have a pocket mask/face shield or the person is known to be non-infectious.	 4 Stay with them Naloxone only lasts for 30–90 minutes. Stick around until help arrives. They'll still need professional medical care.

If no response after two minutes, administer a second dose of Naloxone in their other nostril. Continue giving additional doses of naloxone every two minutes if no response.

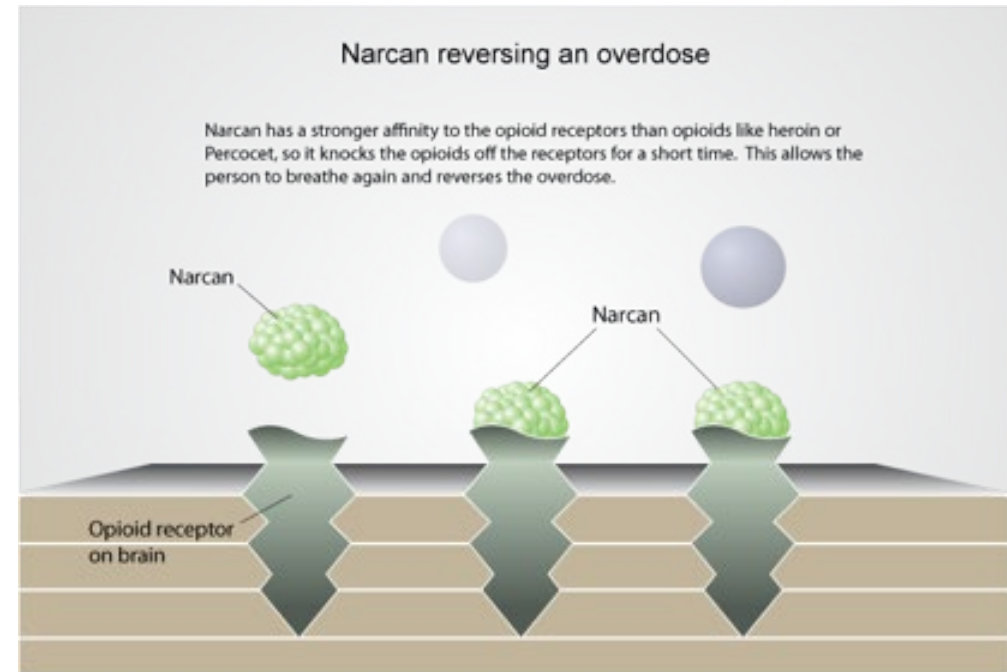

Naloxone Can Be Used On

- Pregnant Women
- Babies over 28 days of age
- Children, Teens, Adults
- Persons experiencing an opioid overdose
 - Intentional drug use
 - Accidental exposure
 - **Prescription Opioid Pain Medications**
 - Toddlers, Babies, Infants
 - Elderly adults who may forget they have already taken their pain medication
- Naloxone Expiration Date (Bottom of the Box)
- Temperature for storing (Below 77 degrees)
 - Excursions permitted up to 104 degrees
 - Do not freeze or expose to excessive heat above 104 degrees
 - Protect from light
- OK to Travel with Narcan (FDA Approved Medication)
- **In Mexico, Narcan is considered a psychoactive drug. A prescription is required to have Narcan/Naloxone in Mexico.**



Narcan - Naloxone

- Fire Extinguisher and Smoke Alarm
- Have them and hope you never need them.
- Same with Narcan – Naloxone...

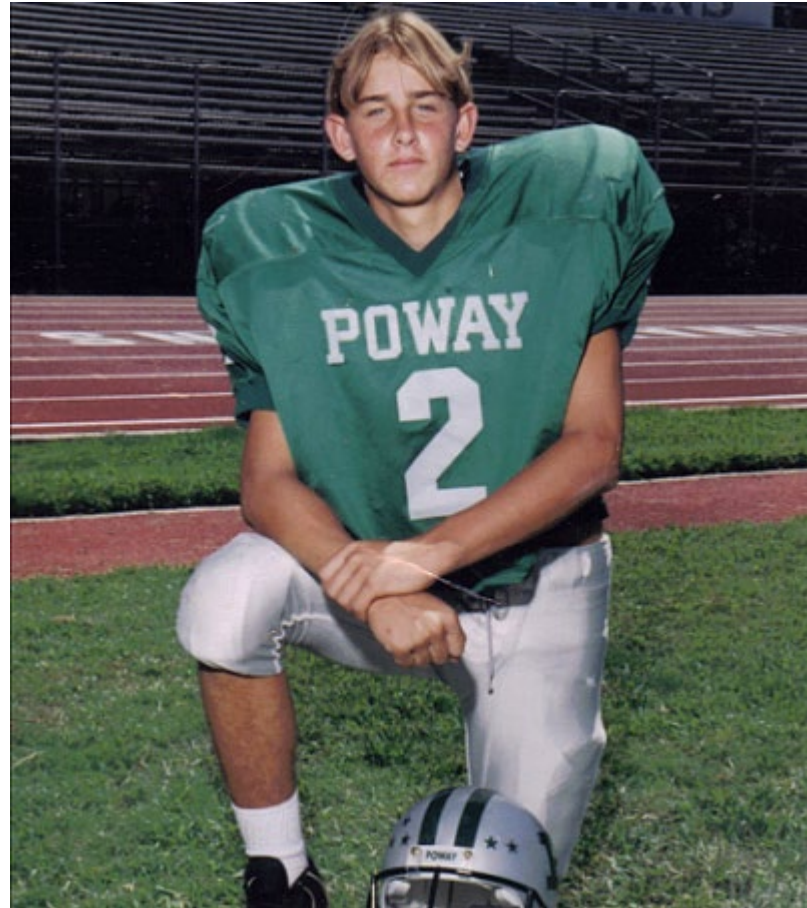

Protection Law”

- **California Health and Safety Code Section 11376.5**
 - It shall not be a crime for a person to be under the influence of, or to possess for personal use, a controlled substance, or drug paraphernalia, **IF that person, in good faith, seeks medical assistance for another person experiencing a drug-related overdose that is related to the possession of a controlled substance.**
 - **Includes the person experiencing the overdose or one or more other persons at the scene of the overdose, who in good faith, seek medical assistance for the person experiencing the overdose.**
 - **Law Effective on January 01, 2013**

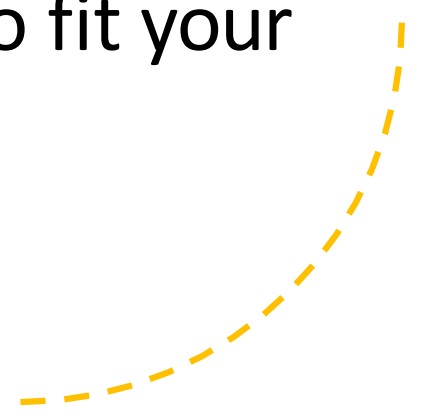

AB 2998 Opioid Overdose Medication- Pupil Administration (49414.35 Education Code)

- Prohibits LEAs from prohibiting a pupil 12 years of age or older, while on a school site or participating in school activities, from carrying or administering, for the purposes of providing emergency treatment to persons who are suffering, or reasonably believed to be suffering, from an opioid overdose, a naloxone hydrochloride nasal spray or any other opioid overdose reversal medication that is federally approved for over-the-counter, nonprescription use.

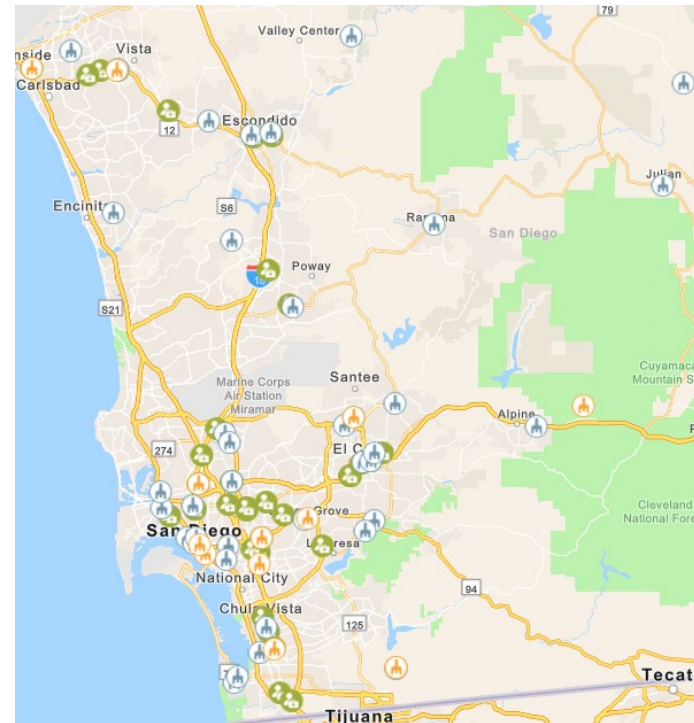

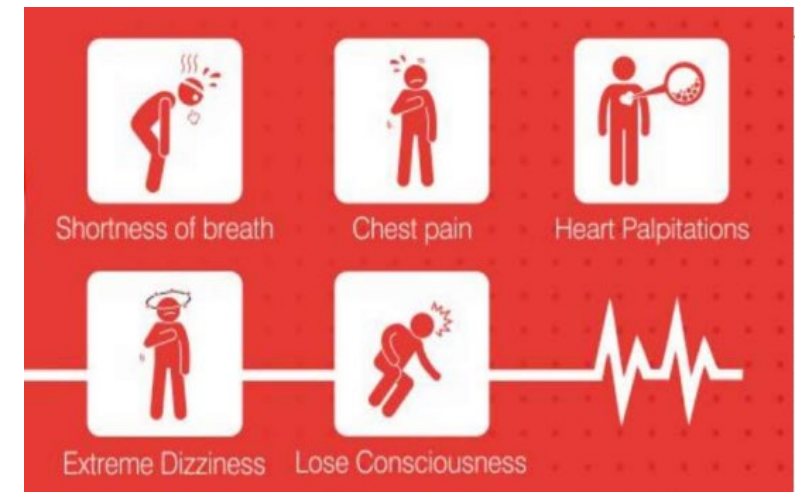
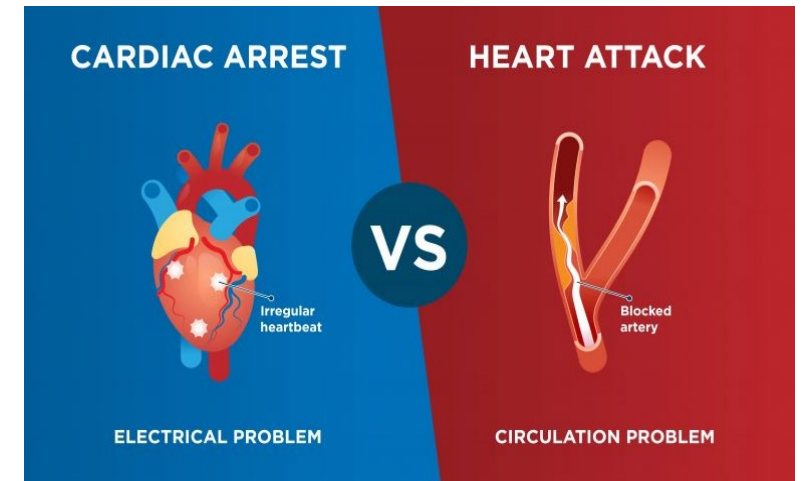
Project ADAM

(Automated Defibrillators in Adam's Memory)

- National non-profit community outreach program that was established in 1999 in memory of Adam Lemel, a 17-year-old who tragically lost his life to sudden cardiac arrest during a high school basketball game.
- **Mission:** Project ADAM saves lives by empowering schools and communities to be prepared for sudden cardiac arrest.
- **Vision:** Eradicate sudden cardiac death through school and community prevention.
- Has saved over 300 lives since 1999

What is Sudden Cardiac Arrest? (SCA)

- When the heart suddenly stops beating due to an irregular heartbeat
- Without treatment, death can occur within minutes
- Can happen to anybody at any age!
- Signs of SCA:
 - Unconscious or unresponsive
 - Not breathing normally
 - Seizure or convulsion like activity
- AED = Automated External Defibrillator
 - Used to evaluate heart rhythm and deliver a shock if needed



Sudden Cardiac Arrest (SCA)



- 350,000+ Sudden Cardiac Arrests happen outside of a hospital each year, with over 90% leading to death
 - Only ~40% of victims have been found to receive bystander CPR
 - Survival decreases by 7-10% each minute without defibrillation
- 1 in 300 youth have an undetected heart condition
 - 23,000+ youth under the age of 18 suffer SCA annually
- Sports related SCA account for ~39% of youth cases
 - #1 cause of death for student athletes

Heart Safe Schools

- Project ADAM strives to assist schools in establishing an emergency plan in the incidence of a SCA.
- Project ADAM provides the foundation for schools to develop their program, including templates, resources, and guidance on how to help prevent sudden cardiac death in the school setting.
- After the completion of the program checklist, the school is designated as “Heart Safe” for three years.
- **California AB 2887 now requires that all schools have a cardiac emergency response plan in place as part of their safety plans moving forward.**

New Guidance About Recess at School



- The American Academy of Pediatrics (AAP) has released the updated guidance about recess at school: [The Crucial Role of Recess in School](#)
- The guidance cites the latest research, emphasizing how recess is vital to supporting good health, academic success, and social and emotional growth.
- Given the benefits of recess, the AAP recommends that recess be protected and never withheld for academic or punitive reasons.

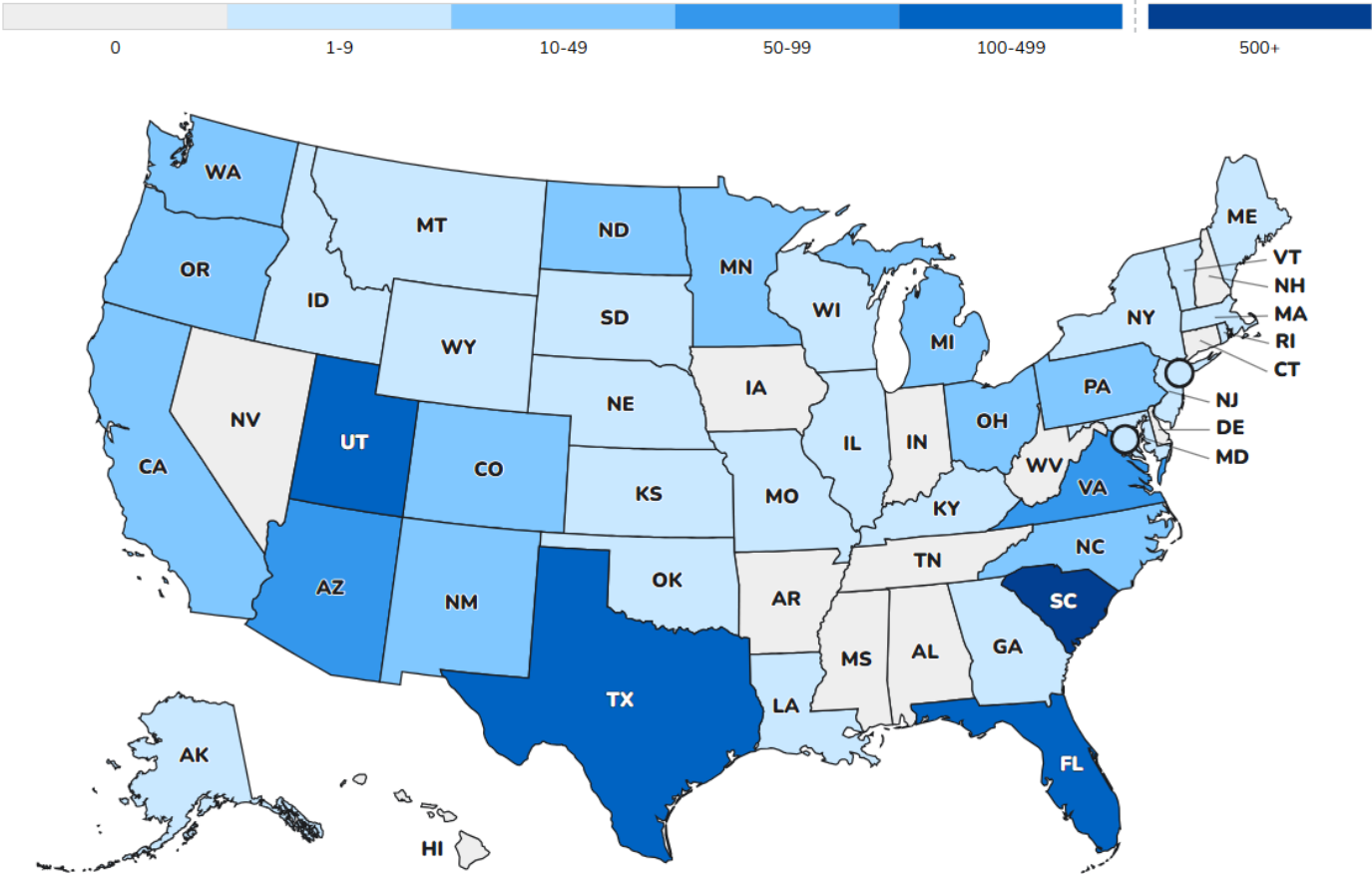

County Reports Two Unrelated Measles Cases



- In May, County public health officials confirmed two unrelated cases of measles.
- Both people who got sick travel to San Diego for work. One of the cases involved public exposure.
- The best prevention against measles is vaccination. With outbreaks reported in several states, officials urge everyone to ensure they are fully vaccinated, especially travelers.
 - Infants between 6 and 12 months of age who travel should get one dose. Anyone over 12 months who travels should receive two doses at least four weeks apart.

West Nile Virus



- County workers found West Nile virus in two dead crows picked up near Rolando and Skyline.
- There are no local human cases so far this year. West Nile virus mainly affects birds, but mosquitoes can pass it to people if they bite an infected bird and then bite a person.
- The County is reminding everyone to follow three steps to protect themselves from mosquitoes: Prevent, Protect, and Report.
- Prevent mosquito breeding at home, protect yourself from bites, and report mosquitoes and dead birds to the Vector Control Program.
