The Jurors of the State of Maryland for the body of the City of Baltimore, do on their oath present that the aforesaid DEFENDANT, late of said City, heretofore on or about between 2011-2012, at 2229 E. Baltimore Street, Baltimore, Maryland, did cause sexual abuse of "Victim Number One," a minor, the defendant being said child's parent, said abuse occurring with "Victim Number Two," also a minor, in violation of Criminal Law Article, Section 3-602(b)(1) of the Annotated Code of Maryland; against the peace, government and dignity of the State.

SECOND COUNT

The Jurors of the State of Maryland for the body of the City of Baltimore, do on their oath present that the aforesaid DEFENDANT, late of said City, heretofore on or about between 2011-2012, at 2229 E. Baltimore Street, Baltimore, Maryland, did cause sexual abuse to Victim Number One, a minor, the defendant being said child's parent, said abuse occurring with Victim Number Three, also a minor, in violation of Criminal Law Article, Section 3-602(b)(1) of the Annotated Code of Maryland; against the peace, government and dignity of the State.


