I, the undersigned, apply for statement of charges and a summons or warrant which may lead to the arrest of the above named Defendant because on or about 2 February 2020 at 2200 blk W. Saratoga St., Baltimore, Md did use a handgun to shoot and murder Marvin Kosh. the above named Defendant On 2 February 20 at approximately 0256hrs, P/O Cassidy (7A14-J529) responded to the 2200 block of W. Saratoga St. (Concise statement of facts showing that there is probable cause to believe that a crime has been committed and that the Defendant has committed it): for a shot spotter alert plus a call for discharging. Upon arrival P/O Cassidy observed a Maroon, 2019 Kia Optima, bearing MD tags# 1EA1340 with an open front passenger door. Sitting in the front passenger seat with what appeared to be multiple gunshot wounds to the torso was the victim, identified as Marvin Kosh (B/M/10-10-90). Baltimore City Fire Department, Medic# 21 also responded and transported Mr. Kosh to University of Maryland Shock Trauma Center for

further medical treatment. However despite all medical efforts, Mr. Kosh was pronounced deceased at 0342hrs by Dr. Cimeno. Crime Lab# 5840 (Scott) responded and processed the crime scene which consisted of the following: 8 - 9mm cartridge casings, blood, and a cigarillo tip. The vehicle was towed to the crime lab bay for processing. Dr. Klein of the Office of the Chief Medical Examiners office conducted an autopsy on the remains of Mr. Kosh on 2 February 20 and ruled his death a Homicide by Shooting.

Investigation revealed Mr. Kosh and Mr. Braxton - Carter was involved in an on going dispute. Mr. Braxton - Carter followed Mr. Kosh to the 2200 block of W. Saratoga St. and shot him multiple times causing his death.

A witness who was present when Mr. Braxton - Carter shot and killed Mr. Kosh was located and interviewed in reference to this incident. The witness was shown a photographic array and identified Mr. Braxton-Carter as the person who killed Mr. Kosh. This witness identification will be kept anonymous at this time, however they will be made available for all future court proceedings.

All events occurred in Baltimore City, State of Maryland.
