On Sunday June 5th 2022 at 2032 hours, BPD Dispatch #56 contacted the Homicide Unit and notified Det. Diener (Unit 2183 H402) of an adult male who was shot in the head and chest in the 200 block of S. Loudon Ave. After receiving the aforementioned information from Det. Diener, your writer and Det. Forbes (H809) responded to the scene and assumed control of this investigation.

Upon arrival, your affiant located P/O Diallo (8C24 K683) who stated that on 6/5/22 at 2028 hours, he responded to the location on a call for a shooting. Upon his arrival, Officer Diallo observed an unknown black male victim, later identified as Mr. Tyrone Walker (9/10/84) laying supine on the sidewalk of the location next to a silver 2014 Jeep 4X4 bearing MD tag 5EF3705. The victim appeared to be suffering from a gunshot wound to the head and the chest. P/O Diallo began to attempt life saving measures on Mr. Walker until BCFD personnel from Medic#15 and Engine #30 arrived on scene. The victim was transported to the RL Cowley Shock Trauma Center where despite all efforts, Mr. Walker succumbed to his injuries and was pronounced deceased on 6/5/22 at 2112 hours by Dr. Herrold. Southwestern District Patrol Units secured the crime scene in the 200 block of S. Loudon Ave.

During the course of this investigation, your affiant received information that (2) black males fled the crime scene on foot headed northbound through the 200 block S. Loudon Ave. Video footage was obtained of these two individuals and witness(es) confirmed same to have participated in this incident. Witness(es) were located and interviewed at which time Mr. Dana Davenport (SID# 3386863) was positively identified as an individual who used a handgun to shoot and kill Mr. Tyrone Walker in the 200 block of S. Loudon Ave on 6/5/22.

Mr. Davenport is prohibited from possessing a regulated firearm.

All events did occur in Baltimore City, State of Maryland.
