

A DSH, spayed female, brown tabby, cat was also removed from inside of the residence (TT #163084) White on-scene, Supervisor Howard met with the Property Manager, Ron Hami, 215-300-1627, who provided him with the information for two tenants: Robert Conley, 443-248-9942 and Michael Porter. Mail and packages in plain view, inside of the residence were addressed to Robert Conley as well as " River of Life". AEO Hughes was able to identify Robert Conley and " River of Life", which appears to be Mr. Conley's kennel name, on social media platforms as well as " Puppies.com" for the purposes of breeding dogs and selling puppies.

All animals were impounded due to their extremely poor living conditions, their health concerns and breeding without a permit. So that dogs could be easily removed from the location and to reduce additional stress on the dogs, a lock on the rear gate was cut to utilize the rear yard exit/entry. Notice of Impoundment was left on the ottoman in the living room along with a copy of the warrant. All doors were closed and secured before leaving the scene. Photos and video taken on scene and upon arrival at the shelter." It is clear to investigators that the animals housed in the upper level were cared for greater than those crated in the basement. Combined with family members on scene, acknowledging that the Cane Corso, which was housed upstairs, was the family's personal animal. This shows that both suspects knew how to and did provide adequate care for animals. This further exclaims the neglect and abuse given to all other animals.

Investigation into the River for Life Company shows no breeding license but does show multiple animals for sale and grooming.
