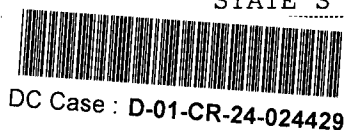

SAYING THAT HE WOULD BEAT MR. [REDACTED] WHILE MR. REED (3RD) STOOD OVER TOP OF HIS HOSPITAL BED IN THEIR DINING ROOM. WHILE SPEAKING TO MR. [REDACTED] IN A SLOW VERBAL STATE, HE ADVISED ME OF SAME INCIDENT AS HE WENT ON TO SAY THAT MR. REED (3RD) THEN PUT BOTH HIS HANDS AROUND HIS NECK AND CHOKED HIM AND PUNCHED HIM IN HIS MOUTH AND CHEST AREA AROUND HIS HEART. MR. [REDACTED] ADVISED THAT HE DID NOT LOSE CONSCIOUS, BUT HE SUSTAINED A BUSTED LIP. MEDIC 13 ARRIVED ON SCENE TO TREAT MR. [REDACTED] MR. REED (3RD) LIVES IN THIS HOME WITH BOTH OF HIS GRANDPARENTS LISTED ABOVE. MS. [REDACTED] ADVISED THAT MR. REED (3RD) THEN PHYSICALLY PUSHED HER DOWN TO THE GROUND, WHILE HER DAUGHTER, MS. [REDACTED] STEPPED IN TO PROTECT HER, MR. REED (3RD) DID THE SAME THING TO HER WHILE OVERPOWERING HER. MR. REED (3RD) REFUSED TO LET MS. [REDACTED] UP UNTIL SHE AGREED TO TAKE HIS TO THE SMOKE SHOP TO BUY HIM MARIJUANA. MS. [REDACTED] THEN CONTACTED 911 AS OFFICERS ARRIVED. BOTH MS. [REDACTED] MS. [REDACTED] AND MR. [REDACTED] DENIED TRANSPORTATION FOR FURTHER MEDICAL TREATMENT. MR. [REDACTED] SUSTAINED MINOR INJURIES. MR. [REDACTED] IS CURRENTLY IN A HOSPICE CARE POSITION WHERE HE IS BED RITTEN WITH PROSTATE CANCER, TRANSITIONING OVER AND UNABLE TO PHYSICALLY DEFEND HIMSELF. MR.
