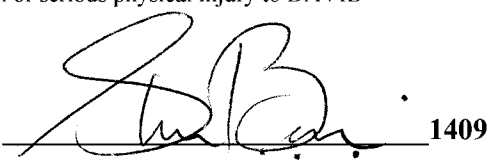

On October 27, 2022, at approximately 3:29 A.M., members of the Southern District responded to 3303 Annapolis Road on the side of the shopping center for a reported on-view shooting by the Baltimore City Fire Department. Upon officer's arrival, units observed a Hispanic male identified with a Maryland License as David Rodriguez Ramirez suffering from multiple gunshot wounds. BCFD Engine #58 responded and Firefighter A. Seitz pronounced Mr. Rodriguez Ramirez deceased at 3:29 A.M.

On October 27, 2022 8:30 A.M., Dr. Jack M. Titus, M.D attending pathologist of the O.C.M.E. conducted the autopsy of David Rodriguez Ramirez. Upon the completion of the examination, it was determined the cause & manner of death is a Homicide by Shooting.

During the course of the investigation commercial camera systems from the shopping center (3300 block of Annapolis Road) were identified. Video footage reviewed by your Affiant, from the aforementioned commercial businesses in the shopping center, confirms the shooting occurred on October 26, 2022, at approximately 9:30 P.M. Video illustrates Mr. Ramirez standing on the exterior of the passenger side of a red 2004 Dodge Ram 1500 bearing Maryland Tag #8FD6972 and an unknown female standing next to him. Both front passenger and driver's door of the red Dodge RAM were open. Directly outside the driver side door of the vehicle, an unknown male suspect discharged a handgun to shoot through the vehicle's open cabin, striking the Mr. Ramirez in the chin and back multiple times.

On October 28, 2022, the aforementioned female witness was identified, whose identity will be provided for court proceedings. Following the interview, coupled with the aforementioned camera footage and social media, a suspect was identified and the witness was shown a photographic array. Upon a systematic review of the photographic array, the witness positively identified photograph #4 bearing the #253135067977 as the person responsible for shooting and killing Mr. David Rodriguez Ramirez. The number displayed on the photograph is associated with the defendant Gerson Onan Diaz Arita.
