I, the undersigned, apply for statement of charges and a summons or warrant which may lead to the arrest of the above named defendant because on or about 9/7/2023 at 1800 block of Presbury Street Baltimore Maryland 21217, the above named defendant

Mr. Kenneth MacKay did stab Mr. Daniel Taylor which contributed to the cause of his death.

(Concise statement of facts showing that there is probable cause to believe that a crime has been committed and that the defendant has committed it):

On 7 September 2023, at approximately 0312 hours, Officers responded to the 1700 Block of McKean Ave in reference to a shot spotter alert. Upon arrival, officers located an adult black male later identified as Daniel Taylor lying face down on the sidewalk in the 1800 block of Presbury Street. Mr. Taylor was suffering from multiple gunshot wounds. A crime scene was established

and a Maryland Identification Card was located, which positively identified the victim as Mr. Daniel Taylor. Medic # 4 responded to the scene and Mr. Taylor was pronounced deceased on scene by Paramedic Logan at 0325 hours. Crime Lab Unit 5857 responded, photographed, and processed the scene. The Office of the Chief Medical Examiner's Forensic Investigator responded and recovered the victim's body from the scene.

An autopsy performed by Doctor Ali revealed the victim Daniel Taylor was not only shot multiple times but he was also stabbed several times in the back of the neck. Doctor Ali ruled the manner of death as a homicide by both shooting and stabbing.

Video footage recovered from a surveillance camera revealed Mr. Daniel Taylor was outside of 1803 Presbury Street, at which time Suspect # 1 walks around the corner onto the 1800 Block of Presbury Street and walks by the victim. Seconds later, Suspect # 2 walks around the same corner as Suspect # 1 with a gun in his hand and shoots the victim several times, at which time the victim falls to the ground on the sidewalk outside of 1805 Presbury Street. Suspect # 2 runs west away from the scene on foot and south into a side alley. Subsequently, Suspect # 1 walks back towards the victim, who is still lying on the ground and stabs the victim three times around the head and neck area. After Suspect # 1 stabs the victim, he walks east on Presbury Street and south on McKean Ave. Suspect # 1 was positively identified by witnesses as Kenneth Alan MacKay, M/B/DOB 07/17/86, SID #2623287.

All events occurred in the city of Baltimore, the state of Maryland.
