**GENERAL RESPONSIBILITIES** Assists in the repair and maintenance of wastewater collection systems for the County in accordance with Federal, State and local laws.

**ESSENTIAL TASKS** include the following; other duties may be assigned

1. Assist in checking sewerage pumping stations, manholes and sewer lines
2. Perform facility and grounds maintenance and general repair
3. Perform electrical and mechanical maintenance of sewer lines, facility equipment, pumps, and motors
4. Maintain equipment and tools
5. Assist in conducting semi-final and final inspections of wastewater hook-ups and maintenance of right-of-ways
6. Complete routine paperwork such as time sheets, logs, and reports
7. Report to work outside of normal work hours for emergency operations
8. Perform related duties as to specific assignments
9. Any employee may be identified as Essential Personnel during emergency situations
10. Provide service to customers by answering questions, providing information, making referrals and assuring appropriate follow-through and/or resolution
11. Communicate with managers, supervisors, co-workers, citizens, and others, maintains confidentiality; and represents the County
