- Receive incoming materials by unloading and opening packages, verifying contents, and entering materials into the inventory system. Move and store all incoming materials in inventory.
- Update Inventory in Visual.
- Load and unload trucks.
- Replenish Factory Inventory with Warehouse Inventory as needed.
- Accept incoming and manage outgoing deliveries and storage of product in warehouse.
- Provide direction to available personnel in completing variety of material handling duties.
- Coordinate and maintain accurate bin locations records.
- Maintain a safe and orderly warehouse.
- Safely operate forklift, reachtruck, and hand truck/pallet jack and maintain in good working condition.
- Accept and disposition all returns per our RMA Process.
- Provide back-up assistance to the Traffic Coordinator in the scheduling of carriers, preparation of Bills
  of Lading and data entry of UPS and FedEx shipping information.
- Package outgoing finished products for shipment, as needed.
- Make pick up and deliveries at vendors when necessary.
- Respond to customers and vendors in a professional, courteous manner.
- Perform other duties as assigned.
