Background: On March 12, 2020, Carroll County Senior & Community Centers were ordered to close by order of Governor Larry Hogan, due to the COVID-19 pandemic. Issue:

2021 Spring Amendment to the 2019 Water and Sewer Master Plan

Background: The Water and Sewer Master Plan is a document that is prepared by the Department of Planning for the purpose of delineating water and sewer service areas, identifying planned projects and calculating water and sewer demand for the County and the eight municipal systems.

The County typically provides opportunities for amendments twice a year, one in the Spring and one in the Fall, to address changing conditions and circumstances. "County 9-1-1 Fee"

Background:

In accordance with the "Maryland Public Safety Article", Subtitle 3-9-1-1 Emergency Telephone System, § 1-311. County 9-1-1 fee, Carroll County has the authority to establish and apply a 'county 9-1-1 fee'. Unless justified otherwise in accordance with the requirements set forth in this Article, the county fee shall not exceed \$0.75 per month for each switched local exchange access service, CMRS, or other 9-1-1-accessible service provided. If revenues attributable to the county 9-1-1 fee for a fiscal year do not provide the revenues necessary to cover a county's operational costs for the 9-1-1 system for that fiscal year, the county may, for the following fiscal year, impose a county 9-1-1 fee not exceeding \$1.50 per month for each switched local exchange access service, CMRS, or other 9-1-1-accessible service provided. The new county 9-1-1 fee would remain in effect until repealed or modified by a subsequent county ordinance or resolution and may not exceed a level necessary to cover the total eligible maintenance and operation costs of the county.

Based on the deficit (\$1,625,521) documented in the annual audit of Carroll County's FY2020 9-1-1 Revenue and Expenditures, we believe an adjustment of the county's current 9-1-1 fee to \$1.50 is justified. Accordingly, we propose the Board of County Commissioners set the local 9-1-1 fee at this rate. Should the Maryland 9-1-1 Board deem a lesser rate is warranted, we propose the Commissioners set the county fee at the maximum rate permitted by same. Following today's presentation, the next step required to change the local 9-1-1 fee is to hold a public hearing on the matter; we respectfully request the Board please approve doing so.

Discussion/Decision – Rural Legacy Program Option to Purchase on the S. Scott Alban, 3669 Basler Road, Manchester, District 1.

Background:

A 107.014-acre farm property owned by S. Scott Alban located at the above address was granted preliminary approval to participate in the Maryland Rural Legacy Program by the County Agricultural Land Preservation Advisory Board on January 13, 2021. The easement will be purchased using only state Rural Legacy Program grant funds at a direct cost of \$675,283.70. Notice of Intent to purchase a conservation easement on the property has been duly advertised.

The Option signed by the owners provides 120 days for the Commissioners to exercise the Option thereby converting it to a Contract of Sale. The Maryland Department of Natural Resources Rural Legacy Program has approved the purchase through a grant agreement with Carroll County and the County and the landowner are ready to proceed to the easement settlement stage.
