DDA Authorized Services Report Enhancement Overview

Overview

In the March 2024 maintenance, MDH updated the DDA Authorized Services Report. Users are now able to view both annually authorized and monthly authorized services in a single output and can have a summary of billed services across calendar years.

This process was updated to more accurately display authorized services and the amounts billed towards the authorization cap.

Summary of system changes:

- Change in input from Annual and Monthly service authorization to Service Plan Year
- Change in report limitation to display future month authorization based on approved PCPs.
- New outputs to include additional service plan and eligibility information

Please review the below instructions for more information about what changes you can expect.

Input changes

1. The new “Service Plan Year” input will replace the Annual vs Monthly authorized services, enabling users to see both authorization types. You will instead be prompted to select a year. You will also be able to select multiple months in the year if desired.

Output Detail Changes

1. When viewing an annually authorized service, if the authorization crosses calendar years, all authorizations and units/costs billed against the authorization will now appear in the report
2. You will also be able to determine if the service is annually authorized or has monthly authorization by looking to the Service Plan Period. Annual authorizations will have a year span and monthly will only have a month span
