### Automatic Disqualifiers – Illegal Drugs

Applicants will be disqualified if been involved in any of the following:

- Ever illegally sold, produced, cultivated, distributed or transported a drug
- Illegally used a drug within 3 years (2 for PSA/Communications)
- Illegally used a drug while employed as a law enforcement officer
- Ever used Heroin, PCP, LSD, Mushrooms, or Ecstasy

Applicants will be disqualified if Illegal Drug History is in excess of:

- Marijuana more than 20 times or 5 times since 21 years of age.
- Other drugs more than 5 times or 1 time since 21 years of age.

#### Additional Automatic Disqualifiers

Applicants will be disqualified if been involved in any of the following:

- Committed, involved in, or convicted of a felony or serious misdemeanor
- Visible Body Mutilation Applicants are not permitted visible body mutilation to include "plug" or "gauge" style earrings
- Visible Tattoos Applicants are not permitted to have visible tattoos on hands/neck/face/head. Tattoos must not be offensive in nature (regardless of location)
