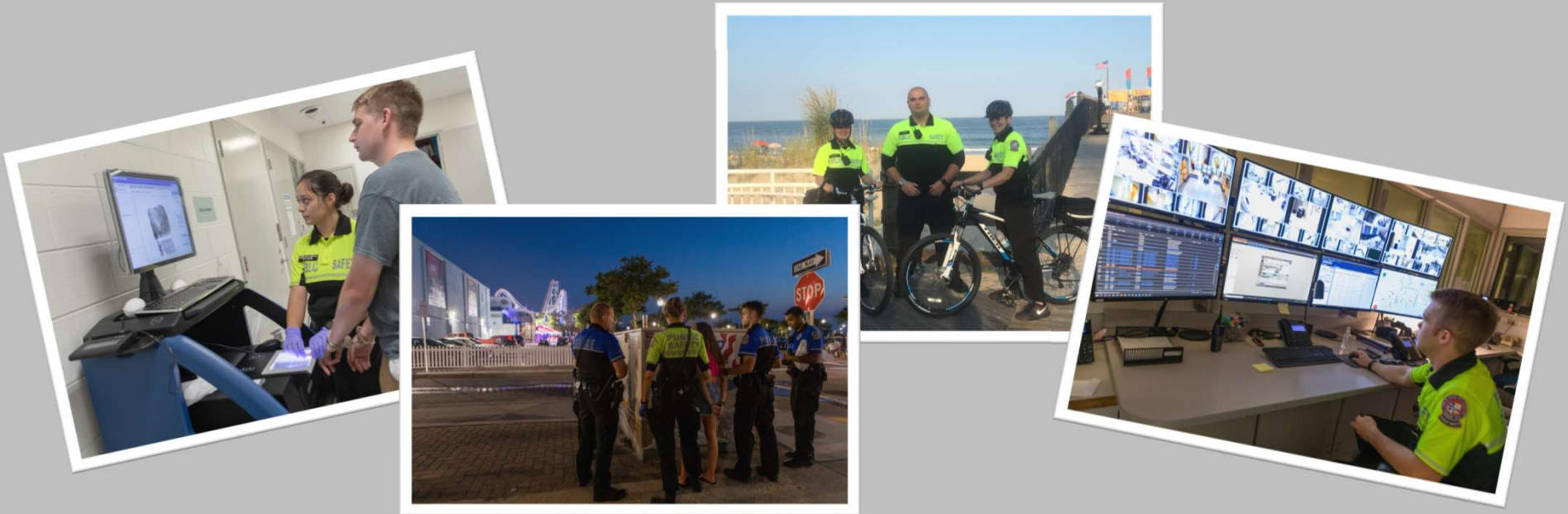
## Minimum Requirements for Seasonal Public Safety Aide

- United States Citizen
- Valid Driver's License
- High School Diploma or GED
- 17.5 years of age
  - \*by May 21<sup>st</sup>, 2023\*
- Good Personal History

\*as determined by Background Investigation\*

# Seasonal Public Safety Aide

- Assisting in the processing and court appearances of prisoners, fingerprinting, and property retention
- Completing police reports on minor crimes and miscellaneous incidents through “walk-in” complaints
- Providing assistance to citizens who seek police service or information
- Answering emergency and non-emergency telephone calls and directing calls to the appropriate extension
- Assist Patrol Division with prisoner transports, parking citations, towing of vehicles and ordinance violations

# Automatic Disqualifiers – Illegal Drugs

Applicants will be disqualified if been involved in any of the following:

- Ever illegally sold, produced, cultivated, distributed or transported a drug
- Cannot have any marijuana usage since June 1<sup>st</sup>, 2022
- Illegally used any other drug within 3 years (2 for PSA/Communications)
- Illegally used a drug while employed as a law enforcement officer
- Ever used Heroin, PCP, LSD, Mushrooms, or Ecstasy

Applicants will be disqualified if Illegal Drug History is in excess of:

- Drugs (non THC)– more than 5 times or 1 time since 21 years of age.

# Additional Automatic Disqualifiers

Applicants will be disqualified if been involved in any of the following:

- Committed a felony or serious misdemeanor
- Visible Body Modification – Applicants are not permitted visible body modification to include “plug” or “gauge” style earrings
- Visible Tattoos – Applicants are not permitted to have visible tattoos on hands/neck/face/head. Tattoos must not be offensive in nature (regardless of location)

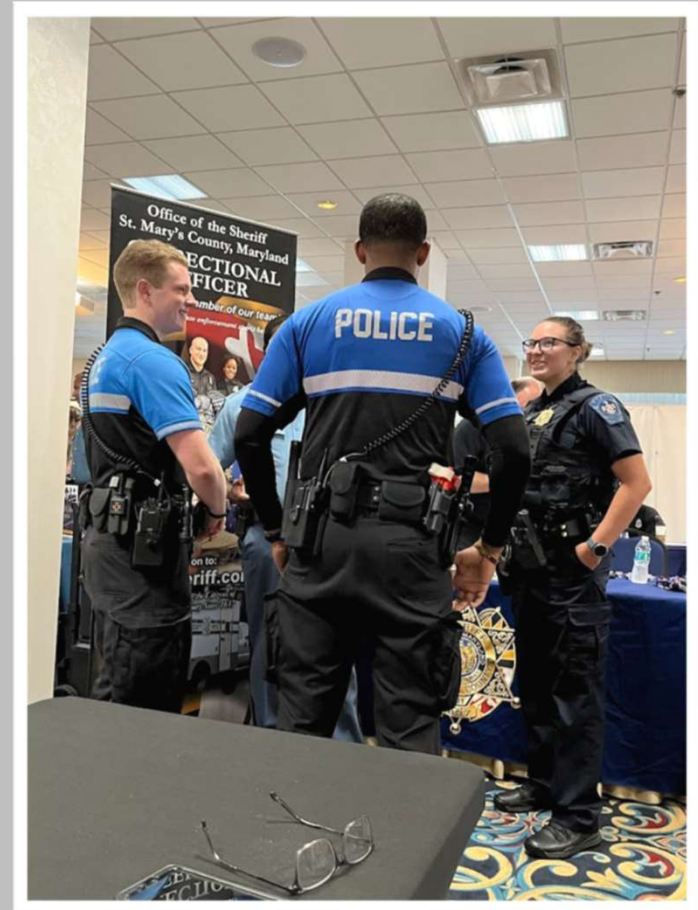
