AUTOMATIC DISQUALIFIERS – ILLEGAL DRUGS

Applicants will be disqualified if been involved in any of the following:

- Ever illegally sold, produced, cultivated, distributed or transported a drug
- Cannot have any marijuana usage since June 1st, 2023
- Illegally used any other drug within 3 years (2 years of Public Safety Aide)
- Illegally used a drug while employed as a law enforcement officer
- Ever used Heroin, PSP, LSD, Mushrooms, or Ecstasy

Applicants will be disqualified if Illegal Drug History is in excess of:

 Drugs (non THC)-more than 5 times or 1 time since 21 years of age

ADDITIONAL AUTOMATIC DISQUALIFIERS

Applicants will be disqualified if been involved in any of the following:

- Committed a felony or serious misdemeanor
- Visible Body Modification Applicants are not permitted visible body modification to include "plug" or "gauge" style earrings
- Visible Tattoos Applicants are not permitted to have visible tattoos on hands/neck/face/head. Tattoos must not be offensive in nature (regardless of location)

Public Safety Aide

- \$17.38/ hr with OT opportunities
- \$250 Sign-on bonus after academy completion
- \$250 Stay-on bonus if return/stay until October 3rd, 2024


