16	WHEREAS, the Vision Zero Action Plan is the Prince George's County roadmap to					
17	achieving zero fatalities and serious injuries on our roadways by 2040. The Action Plan i					
18	data-driven and human-inspired.					
19	WHEREAS, the success of Vision Zero depends on leaders throughout our community and					
20	avary individua	every individual in doing their part to ensure that our transportation system and our drivin				

1	behavior is safe for all roadway users.			
2	WHEREAS, speed kills. Higher vehicle speeds increase the likelihood of a pedestrian			
3	fatality when struck by a vehicle.			
4	WHEREAS, this Speed Monitoring System bill is key to achieving zero fatalities and			
5	serious injuries in Prince George's County; now, therefore			
6	SECTION 1. BE IT ENACTED by the County Council of Prince George's County			
7	Maryland, that Section 26-114.01 of the Prince George's County Code be and the same is hereby			
8	repealed and reenacted without amendments:			
9	SUBTITLE 26. VEHICLES AND TRAFFIC.			
10	DIVISION 4. SPEED REGULATIONS.			
11	Sec. 26-114.01. Authority to install and utilize speed monitoring systems.			
12	(a) Pursuant to Section 21-809 of the Transportation Article of the Annotated Code of			
13	Maryland, as may be amended from time to time, Prince George's County is authorized to use			
14	Speed Monitoring Systems to regulate traffic.			
15	(b) The Director, in conjunction with the Chief of Police, and the County Council is authorized			
16	to determine those locations where speed monitoring systems are to be installed.			
17	(c) All speed monitoring systems shall conform to, and be used in accordance with, the			
18	requirements of the Transportation Article of the Annotated Code of Maryland.			
19	SECTION 2. BE IT ENACTED by the County Council of Prince George's County,			
20	Maryland, that Section 26-114.02 of the Prince George's County Code be and the same is hereby			
21	added:			
22	SUBTITLE 26. VEHICLES AND TRAFFIC.			
23	DIVISION 4. SPEED REGULATIONS.			
24	Sec. 26-114.02. Authority to install and utilize residential district speed monitoring			
25	systems.			
26	(a) Pursuant to Section 21-809 of the Transportation Article of the Annotated Code of			
27	Maryland, as may be amended from time to time, Prince George's County is authorized to use			
28	Speed Monitoring Systems, as set forth in Section 26-114.01 of this Code and Residential Distriction			
29	Speed Monitoring Systems as set forth in Section 26-114.02 of this Code to regulate traffic.			
30	(b) "Residential district" means an area that: (1) Is not a business district; and (2) Adjoins and			
31	includes a highway where the property along the highway, for a distance of at least 300 feet, is			

1	improved mainly with residences or residences and buildings used for business, pursuant to
2	Section 21-101 of the Transportation Article of the Annotated Code of Maryland.
3	(c) Section 21-809 of the Transportation Article of the Annotated Code of Maryland applies to
4	a violation of Subtitle 8, Speed Restrictions of the Transportation Article of the Annotated Code
5	of Maryland, as applied in Prince George's County, recorded by a speed monitoring system that
6	meets the requirements of Section 21-809 and has been placed in Prince George's County, on a
7	highway in a residential district, as defined in Section 21-101 of the Transportation Article of the
8	Annotated Code of Maryland, with a maximum posted speed limit of up to and including 35
9	miles per hour, which speed limit was established using generally accepted traffic engineering
10	practices.
11	(d) A [regional] residential district speed monitoring system may not be used in a local
12	jurisdiction under Section 21-809 of the Transportation Article of the Annotated Code of
13	Maryland unless its use is authorized by the governing body of the local jurisdiction by local law
14	enacted after reasonable notice and a public hearing.
15	(e) The Director of the Department of Public Works and Transportation, in conjunction with the
16	Chief of Police and the County Council is authorized to determine those locations where
17	residential district speed monitoring systems are to be installed.
18	(f) All residential district speed monitoring systems shall conform to, and be used in accordance
19	with, the requirements of the Transportation Article of the Annotated Code of Maryland.
20	SECTION 3. BE IT FURTHER ENACTED that prior to the installation of the first
21	residential district speed monitoring system pursuant to this Section, the County Council shall
22	hold at least one (1) public hearing to obtain public comment on potential locations for such
23	residential district speed monitoring systems.
24	SECTION 4. BE IT FURTHER ENACTED that the Citizen Advisory Committee
25	established by the Director of the Department of Public Works and Transportation, pursuant to
26	CB-37-2009 (DR-2), is now amended and the Citizen Advisory Committee shall be comprised of
27	the following: two (2) representatives from each Council District selected by the respective
28	Councilmembers, two (2) representatives from each At-Large Council Member and three (3)
29	representatives from the Office of the County Executive for a total of twenty-five (25) members
30	to meet periodically for the purpose of obtaining additional public comment but not for decision-
31	making.

SECTION 5. BE IT FURTHER ENACTED that for the first 30 days after the first residential district speed monitoring system is placed in the County pursuant to this Act, a violation recorded by any residential district speed monitoring system in the County may be enforced only by the issuance of a warning.

SECTION 6. BE IT FURTHER ENACTED that the provisions of this Act are hereby declared to be severable; and, in the event that any section, subsection, paragraph, subparagraph, sentence, clause, phrase, or word of this Act is declared invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the remaining words, phrases, clauses, sentences, subparagraphs, paragraphs, subsections, or sections of this Act, since the same would have been enacted without the incorporation in this Act of any such invalid or unconstitutional word, phrase, clause, sentence, paragraph, subparagraph, subsection, or section.

SECTION 7. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45) calendar days after it becomes law.
