Two ways to promote your farm equipment for sale

- 1. **Digitally, before the show:** Fill in this form by Dec. 27. The entries will be organized into a paper directory and tacked onto the bulletin board at the show. You cannot adjust your info after you submit it.
- 2. **On-site, at the show:** Create a pre-written classified. When you get to the show, add it to the bulletin board. For example, use an 8.5x11 flyer, tear sheets, note cards, labeled photographs, etc.

- Come to the MDACF's Agricultural Trades Show at the Augusta Civic Center.
- Doors open daily at 9 a.m. There is no admission fee.
- View the Listening Post bulletin board, which is next to the main lobby and building entrance.
