- Al and the Aroostook District Liaison have been put on the Contact Tracing Team as Monitors for the newly Sara Alert system. Sara Alert is a web-based monitoring tool that contact tracers will use to send daily emails, texts and/or phone calls to cases and identified close contacts throughout their isolation/quarantine monitoring period. This technology enhances the contact tracer's ability to promptly respond and provide guidance to symptomatic individuals.

 - Term PUI – Person Under Investigation may be unsettling to the public.

RoundTable: How is/has coronavirus impacting your work?

- Jennifer S
 - Serving many more meals on wheels requests. From 8,000 to 13, 000 meals in April.
 - Responding requests for people coming back from snow birding who need to isolate. Grocery Shopping Supports & Etc.
 - There are concerns about in-home support PSS, best practices.
 - There are increased calls from family caregivers who carry larger burdens with no respite
- Angela
 - Many cancer patients have had to take different treatments then they were initial expecting, patients are having to go in by themselves, we are finding After/Home Care Treatment is having gaps & patients have misinformation.
 - People who need to be quarantining are having to break their quarantine for essentials like medicines and food.
 - We are seeing increased anxiety in patients who are unsure and asking for consultations.
 - We are working on getting technology in rural areas to older adults to increase their ability to communicate with doctors.
 - Smile Masks: Making face shield masks for people who need to read lips. If anyone is interested in the smile masks or know of who may need them. email me at angela@healthyacadia.org
- Lynn Leighton
 - Hospital has a tent to do testing
 - Care manager more calls to patients
 - A COVID19 Hotline has been created.
 - Different pathways, section off places, cafeteria effected, single point of entry
 - Elective Surgery planning is beginning.

 - Tribal Communities have the ability to close off the community, unlike other communities.
 - Working to provide safe drinking water to Elders & others who need it.

Health Literacy Committee

- Health Literacy is a big idea and we are trying to move it to a doable level
- Identified Areas of Concern
 - Conversations with primary care provider and their patients
 - Medication management & understanding
 - When English is not your primary language.
 1. Educating primary care around culturally appropriate language.
 - The information health centers are giving out; Flyers and pamphlets- do they really make sense, are they at the educational level of the reader.
 - Lois - Shellfish harvesters. People are not understanding the language in the notifications. Bad shellfish gets consumed.
 - Immediate Health Literacy Concerns – related to COVID19 basic facts not being well disseminated.

Jen, SCEC - Economic Impact:

- It has been said that Statewide/nationwide 25% businesses closing. Some communities will be hit harder than others.

Emergency Management Update:

Andrew Braley:

- In charge of PPE Requests. Who the state deems priorities. Dentist. Only certain dentists get PPEs. Dentists are being turned away.
- If you need resources, they are willing to assist in looking to find and secure vendors. Local and commercial vendors.
- Respiratory Protection Plan, Fit testing requirement for N95, medical evaluation qualitative test



Megan Melville:

- RPP – Available to help with creating a Respiratory Protection plan. HCCNM has a template and they are willing to assist organizations.
- Pandemic Planning needs to start now – documenting information, chronologically, it will help in making your plan. Statewide pandemic plan is going to be created beginning in July.

Lynn & Andrew, via Andrew

- Distribution of cloth masks to the Department of Education for lunch people and bus drivers.
- Meal Programs – may continue through the summer
- Public Assistance Grant – working on it, defray covid19 response costs
- A number of zoom meetings
- New round of FEMA federal masks are coming, for Haz-mat high consequence sites.
- Reconstitution efforts, recovery efforts economic and operational are beginning
