## What Grand Haven BLP wants to do:

Under application No. APP-2021-0054, Grand Haven BLP is requesting to install and operate a new combined heat and power plant consisting of five natural gas-fired reciprocating internal combustion engines.

The public comment period and public hearing are to allow all interested parties the opportunity to comment on the proposed conditional approval of a Permit to Install (PTI). It has been preliminarily determined that the installation of new equipment will not violate any of EGLE's rules nor the National Ambient Air Quality Standards. The facility's impact will also not exceed the available increments for nitrogen oxides.
