### HYBRID DETROIT REVENUE ESTIMATING CONFERENCE

The City is required by State law to hold independent revenue conferences in September and February each fiscal year to set the total amount available to be budgeted for the next four years. The conference is held to review the economic outlook and approve revised revenue estimates.

Pursuant to the Michigan Open Meetings Act as amended, which authorizes the continued use of hybrid electronic meetings to provide virtual public participation in accordance with the requirements of MCL 15.263a(2), the OCFO Office of Budget shall conduct its **February 12, 2024 Detroit Revenue Estimating Conference** as a hybrid meeting to protect the public, participants, and board members' health.
