MDHHS announces more community meetings to inform public about upcoming work requirements for Healthy Michigan Plan

Dearborn, Saginaw, Thumb Area forums added

LANSING, Mich. – The Michigan Department of Health and Human Services (MDHHS) has scheduled additional regional forums regarding work requirements for Healthy Michigan Plan beneficiaries.

The forums are part of the department's efforts to preserve coverage for Healthy Michigan Plan beneficiaries.

MDHHS is announcing three additional forums, with one in Dearborn and one in Saginaw. MDHHS is also partnering with local health departments to host a "virtual" forum in the Thumb region.

The forums began Oct. 21 and are being held at locations around the state. The goal is increasing awareness about new work requirements for the Healthy Michigan Plan that are effective Jan. 1, 2020, and preparing beneficiaries to meet the new requirements. Beneficiaries, health care providers, health plans, community organizations and the general public are invited to participate in these forums.

"At MDHHS, we want to do all we can to preserve health care coverage for Healthy Michigan Plan beneficiaries," said MDHHS Director Robert Gordon. "That's why we are joining community partners throughout the state to hold these forums, and directly helping beneficiaries understand the steps necessary to maintain their coverage."

MDHHS is implementing the new work requirements to comply with legislation approved in 2018. Healthy Michigan Plan beneficiaries will be required to report 80 hours of work or other activities, such as job searches, to MDHHS each month.

Healthy Michigan Plan beneficiaries can be excused from the requirements in some circumstances. Beneficiaries who are not excused from the requirements and fail to report may lose their health care coverage.

More than 640,000 Michiganders have coverage under the Healthy Michigan Plan, the state's expanded Medicaid program that began in 2014.
