Re: PCE System 1915 (i) SPA Implementation

DWIHN will be moving forward with adding the 1915 (i) spa benefit form to the Integrated Biopsychosocial Assessment (IBPS) in MHWIN. The DWIHN date for implementation will be June 15, 2023. Since approval of 1915 (i) spa services are driven by an assessed need, DWIHN chose to add the form to the IBPS. Adding the form to the IBPS allows time for the service to be approved for authorization prior to completing the Individual Plan of Service (IPOS). Please contact your PCE programmers to incorporate the 1915 addition to the IBPS. **DWIHN requests that all CRSP providers add the 1915 (i) benefit form to the IBPS no later than June 15, 2023.**

In addition, DWIHN has developed a '1915 (i) spa,' Program Assignment in MHWIN. DWIHN-IT department deployed a mass enrollment of all potential 1915 beneficiaries under this program in MHWIN. This program assignment is associated with service utilization guidelines (SUG) for all 1915 (i) spa services. This step was an additional measure to ensure that all beneficiaries eligible to receive 1915 services have final approval by DWIHN before services are authorized in the IPOS.

For members that do not require any 1915 service, there is a "YES/NO" option to bypass this section in the IBPS.
