Michigan law defines a collection agency as a person directly or indirectly engaged in soliciting a claim for collection or collecting or attempting to collect a claim owed or due, or asserted to be owed or due another, or repossessing or attempting to repossess a thing of value owed or due, or asserted to be owed or due another arising out of an expressed or implied agreement.

The Department currently oversees the practice of approximately 713 collection agencies and 525 collection agency managers.

The Elevator Safety Board has the responsibility to promulgation of rules, preparation of examinations, and issuance of elevator contractor licenses.

In addition to the METRO Authority functions, the new authority will be responsible for distributing personal property tax replacement revenue to municipalities throughout the state according to specific statutory formulas. Underlying all duties is the responsibility of the board to promote and protect the public's health, safety, and welfare. This responsibility is implemented by the Board by ascertaining minimal entry level competency of health practitioners and verifying continuing education during licensure. The Board also has the obligation to take disciplinary action against licensees who have adversely affected the public's health, safety, and welfare.

- 2 seats representing Chiropractors. Current term expires on 12/31/23 for both seats.

### **Michigan Board of Dentistry**

The Michigan Board of Dentistry was originally formed with the enactment of Public Act 122 of 1919 and regulated the practice of dentistry and dental hygiene and authorizing dental assistants.

### **Michigan Board of Licensed Midwifery**

The Michigan Board of Licensed Midwifery establish and implement the licensure program for the practice of midwifery in the state.

The Michigan Board of Marriage and Family Therapy was created to license and regulate the practice of marriage and family therapy in Michigan. Michigan law defines the practice of marriage and family therapy as the providing of guidance, testing, discussions, therapy, instruction, or advice that is intended to avoid, eliminate, relieve, manage or resolve marital or family conflict or discord, to create, improve, or restore marital or family harmony, or to prepare couples for marriage. The Public Health Code mandates certain responsibilities and duties for a health professional licensing board. Underlying all duties is the responsibility of the Board to promote and protect the public's health, safety, and welfare and to take disciplinary action against licensees who have adversely affected it.

Appointment opportunities:

- 3 seat representing marriage and family therapists. The current terms expire on 6/30/2023.
- 1 seat representing the general public. The current term expires on 6/30/2023.

### **Michigan Board of Massage Therapy**

*Department: Licensing and Regulatory Affairs*

*Board Members: 11*

*Term Length: 4 years*

The Michigan Board of Massage Therapy amends the Public Health Code to provide for the licensure of massage therapists. The regulation of any health profession is intended to ensure the public that the people who are identified as a specific type of health professional are qualified to practice.

### **Michigan Board of Medicine**

The Michigan Board of Medicine was formed for the examination, regulation, licensing and registration of physicians and surgeons in the State of Michigan, and for the discipline of offenders against the Act.

- 1 seat representing genetic counselors. The current term expires on 12/31/2023.

### **Michigan Board of Nursing Home Administrators**

*Term Length: 4 years*

The Michigan Board of Nursing Home Administrators was created to license nursing home administrators in Michigan. The practice of a nursing home administrator, as defined in the Public Health Code, means planning, organizing, directing, and controlling the total operation of the nursing home on behalf of the governing board or owner of a nursing home.

The Public Health Code mandates certain responsibilities and duties for a health professional licensing board. Underlying all duties is the responsibility of the board to promote and protect the public's health, safety, and welfare. The Board implements this responsibility by ascertaining minimal entry-level competency of nursing home administrators. The Board also has the obligation to take disciplinary action against licensees who have adversely affected the public's health, safety and welfare.

Appointment opportunities:

- 2 seats representing the general public. The current terms expired on 6/30/2022.
- 1 seat representing nursing home administrators. The current term expires on 6/30/2023.

### **Michigan Board of Occupational Therapists**

*Department: Licensing and Regulatory Affairs*

*Board Members: 9*

*Term Length: 4 years*

The Michigan Board of Occupational Therapists is responsible for the responsibilities and duties for a health professional licensing board. Underlying all duties is the responsibility of the Board to promote and protect the public's health, safety and welfare. This responsibility is implemented by ascertaining minimal entry level competency of occupational therapists and occupational therapy assistants. The Board also has the obligation to take disciplinary action against registrants who have adversely affected the public's health, safety, and welfare.

Appointment Opportunities:

- 3 seats representing the general public. The current terms expired on 12/31/2021.
- 1 seat representing occupational therapists. The current term expired on 12/31/2022.
- 1 seat representing a public member who is a physician licensed under part 170 or 175. The current term expires on 12/31/2023.

## **Michigan Board of Optometry**

*Department: Licensing and Regulatory Affairs*

*Board Members: 9*

*Term Length: 4 years*

The Michigan Board of Optometry currently oversees approximately 1,627 optometrists.

The Public Health Code mandates certain responsibilities and duties for a health professional licensing board. Underlying all duties is the responsibility of the board to promote and protect the public's health, safety, and welfare. This responsibility is implemented by the Board by ascertaining minimal entry level competency of health practitioners and verifying continuing education during licensure. The Board also has the obligation to take disciplinary action against licensees who have adversely affected the public's health, safety, and welfare.

Appointment opportunities:

- 2 seats representing optometrists. The current terms expired on 6/30/2022.
- 4 seats representing the general public. Two seats expired on 6/30/2022, and two seats expire on 6/30/2023.

## **Michigan Board of Osteopathic Medicine and Surgery**

*Department: Licensing and Regulatory Affairs*

*Board Members: 11*

*Term Length: 4 years*

The practice of osteopathic medicine and surgery, as defined in the Public Health Code, means a separate, complete, and independent school of medicine and surgery, utilizing full methods of diagnosis and treatment in physical and mental health and disease, including the presentation and administration of drugs and biologicals, operative surgery, obstetrics, radiological and other electromagnetic emissions, and placing special emphasis on the interrelationship of the musculoskeletal system to other body systems.

The Public Health Code mandates certain responsibilities and duties for a health professional licensing board. Underlying all duties is the responsibility of the Michigan Board of Osteopathic Medicine and Surgery to promote and protect the public's health, safety, and welfare. This responsibility is implemented by the Board by ascertaining minimal entry level competency of health practitioners and verifying continuing medical education during licensure. The Board also has the obligation to take disciplinary action against licensees who have adversely affected the public's health, safety, and welfare.

Appointment opportunities:

- 1 seat representing the general public. The current term expired on 12/31/2021.

### **Michigan Board of Pharmacy**

*Department: Licensing and Regulatory Affairs*

*Board Members: 11*

*Term Length: 4 years*

The Michigan Board of Pharmacy defines the practice of pharmacy as a health service, the clinical application of which includes the encouragement of safety and efficacy in the prescribing, dispensing, administering and use of drugs and related articles for the prevention of illness and the maintenance and management of health.

Appointment Opportunities:

- 2 seats representing the general public. One expired on 6/30/2022 and the second one expired on 6/30/2023.

### **Michigan Board of Physical Therapy**

*Department: Licensing and Regulatory Affairs*

*Board Members: 11*

*Term Length: 4 years*

The Michigan Board of Physical Therapy defines the practice of physical therapy, as defined in the Public Health Code, means: "the evaluation of, education of, consultation with, or treatment of an individual by the employment of effective properties of physical measures and the use of therapeutic exercises and rehabilitative procedures with or without assistive devices, for the purpose of preventing, correcting, or

alleviating a physical or mental disability. Physical therapy includes treatment planning, performance of tests and measurements, interpretation of referrals, initiation of referrals, instruction, consultative services, and supervision of personnel. Physical measures include massage, mobilization, heat, cold, air, light, water, electricity, and sound.”

## **Michigan Board of Psychology**

*Department: Licensing and Regulatory Affairs*

*Board Members: 9*

*Term Length: 4 years*

The Public Health Code defines the practice of psychology as the rendering to individuals, groups, organizations, or the public of services involving the application of principles, methods, and procedures of understanding, predicting, and influencing behavior for the purposes of the diagnosis, assessment related to diagnosis, prevention, amelioration, or treatment of mental or emotional disorders, disabilities or behavioral adjustment problems by means of psychotherapy, counseling, behavior modification, hypnosis, biofeedback techniques, psychological tests, or other verbal or behavioral means. The practice of psychology does not include the practice of medicine such as prescribing drugs, performing surgery, or administering electro-convulsive therapy.

The Public Health Code mandates certain responsibilities and duties for a health professional licensing board. Underlying all duties is the responsibility of the board to promote and protect the public's health, safety, and welfare. The Board implements this responsibility by ascertaining minimal entry level competency of health practitioners. The Board also has the obligation to take disciplinary action against licensees who have adversely affected the public's health, safety, and welfare.

Appointment opportunities:

- 1 seat representing the general public. The current term expires on 12/31/2022.

## **Michigan Board of Real Estate Brokers and Salespersons**

*Department: Licensing and Regulatory Affairs*

*Board Members: 9*

*Term Length: 4 years*

The Michigan Board of Real Estate Brokers and Salespersons was created to license and regulate the practice of real estate brokers and salespersons in Michigan. Article 25 defines a real estate broker as an

individual or an entity, who with intent to collect or receive a fee, compensation, or valuable consideration, sells or offers for sale, buys or offers to buy, provides or offers to provide market analyses, lists or offers or attempts to list, or negotiates the purchase or sale or exchange or mortgage of real estate, or negotiates for the construction of a building on real estate; who leases or offers or rents or offers for rent real estate or the improvements on the real estate for others, as a whole or partial vocation; who engages in property management as a whole or partial vocation; who sells or offers for sale, buys or offers to buy, leases or offers to lease, or negotiates the purchase or sale or exchange of a business, business opportunity, or the goodwill of an existing business for others; or who, as owner or otherwise, engages in the sale of real estate as a principal vocation.

The Michigan Board of Respiratory Care oversees the licensure requirements and standards for respiratory therapists.
