Legislation at a Glance

The Labor Caucus introduced multiple bills and bill packages to benefit and invest in the hardworking people of our state.



• House Bill 4594, sponsored by Rep. Brenda Carter (D-Pontiac), would restore Michigan's prevailing wage law to pay workers fairly. · House Resolution 65, introduced by Rep. Sarah Anthony (D-Lansing), urges the state and federal government to work with building trades and industry leaders to address worker shortages and increase the number of women and minorities in trades.





· House Bill 4592, sponsored by **Rep. Julie Rogers** (D-Kalamazoo), would enable local communities to enact minimum wage laws, living wage laws, prevailing wage laws, unpaid leave or any benefit more significant than that provided by state law.



· House Bill 4593, introduced by Rep. Samantha Steckloff (D-Farmington Hills), would allow local project labor agreements on publicly funded local projects.





· House Bills 4175 and **4176**, sponsored by **Reps. Darren Camilleri** (D-Trenton) and **Terry Sabo** (D-Muskegon), would repeal Right to Work and allow Michigan workers greater freedom to join a union and get the pay, benefits and protections they deserve.


