ORDER LIFTING SUMMARY SUSPENSION

The Michigan Department Lifelong Education, Advancement, and Potential, by Division Director Erika Bigelow and Acting Bureau Director Courtney Adams, Child Care Licensing Bureau, hereafter referred to as “the Bureau,” orders the lifting of the summary suspension of the license of Licensee, Antioch Church of God in Christ, to operate a child care center pursuant to the authority of the Michigan Administrative Procedures Act, 1969 PA 306, MCL 24.292(2). The Department has found that the public health, safety, or welfare of children no longer requires the emergency action of summary suspension for the following reasons:

1. On or about December 15, 1989, Licensee was issued a license to operate a child care center with a licensed capacity of 97 at 16827 Appoline, Detroit, Michigan 48235.
2. On January 29, 2025, the Bureau issued an Order of Summary Suspension of the license due to conditions that posed imminent risk to the public health, safety, and welfare of the children in care.

3. On February 20, 2025, Licensee Designee Constance Price submitted a food service plan to the Bureau for review. The plan addressed procedures for ensuring accurate temperature monitoring, proper food storage and disposal, compliance with state standards for all meal components, and the cleaning of food service items.
4. On February 25, 2025, Licensing Consultant Sharonda Trammer conducted an on-site inspection at the center and observed the following repairs and/or improvements to the center:
 - a. The temperature throughout the building was appropriate, and there was hot water available in all sinks.
 - b. All spoiled foods were removed from the premises. The refrigerators in all the child use spaces were clean and cleared of old food. There was no foul odor in the building.
 - c. The water in all the water dispensers was observed to be clean and clear. Rooms that did not have water dispensers had gallon jugs of water for use.
 - d. There was a sufficient amount of cleaning supplies available for use. There was a sufficient amount of cups for children's use.
 - e. Cribs were removed from the unapproved child use spaces. An unapproved crib had been removed from the center.
 - f. The torn mattresses were removed and replaced, and the crib sheets were tightly fitted.

- g. There were no combustible materials within four feet of the furnace or boilers in the heat plant rooms.

Given the aforementioned modifications and/or repairs, the Bureau has determined that imminent risk is no longer present, and therefore, Licensee is hereby notified that the summary suspension is lifted effective 12:00 p.m. on February 26, 2025. While this Order lifts the summary suspension, the Bureau maintains its authority under the Child Care Organizations Act, MCL 722.111 et seq., and the administrative rules promulgated under this Act, to pursue other licensing actions based on the facts that led to the summary suspension and/or other information obtained during the special investigation.
