SUBJECT: Determination of Eligibility for Michigan Mandatory Special Education for Infants and Toddlers, Birth to Age Three, Deaf or Hard of Hearing Guidance

The Determination of Eligibility for Michigan Mandatory Special Education (MMSE) for Infants and Toddlers, Birth to Age Three, Deaf or Hard of Hearing (DHH) guidance document is now available. This document was made possible through a joint effort of the Michigan Department of Education (MDE) Office of Special Education, Office of Great Start/Office of Early Childhood Development and Family Education, and MDE Low Incidence Outreach. The document helps promote the appropriate identification and qualification of infants and toddlers, aged birth to three, who are eligible for MMSE in addition to being eligible for *Early On*[®] services.

In addition to the DHH document, previously released guidance for MMSE eligibility categories includes:

- Autism Spectrum Disorder (ASD)
- Early Childhood Developmental Delay (ECDD)
- Other Health Impairment (OHI)
- Speech Language Impairment (SLI)

These guidance documents are intended to inform key stakeholders and, to provide awareness, guidance, professional development, training, and additional supports regarding the appropriate identification of infants and toddlers under MMSE.

The process for creating guidance for the application of <u>Michigan Administrative Rules</u> <u>for Special Education (MARSE)</u> categories for infants and toddlers, birth to age three,
