Passport Application Services at Troy City Hall

The Troy City Treasurer's office now serves as an official Passport Acceptance Agency and accepts applications from U.S. Citizens from 8am-3pm, Monday-Friday. (With the exception of Dec.17- Jan 4, 2013). Photo services are available for a fee at the City Clerk's Office.

Passport fees vary depending on age, if it is a new application or renewal, or if expedited service is required. Current passport info can be obtained on the US Dept. of State website at www.travel.state.gov or by contacting the City Treasurer's office at 248.524.3333.

Michigan Secretary of State, 1111 E Long Lake, 12/13/12: Manager reports that on 12/13/12 a counterfeit \$20 bill was received for payment. It is not known who passed the bill. The counterfeit bill was turned over to the United States Secret Service.

Sears, 300 W Fourteen Mile, 12/16/12, 6:30 pm: Troy Officers were dispatched to the business on report of a credit card fraud in progress. Officers arrived and spoke with Sears Loss Prevention who reported that the suspect had purchased two computers, 3 Nintendo DS, and 2 Sony PS using a Sears credit card. The purchase totaled \$2808.89. Loss Prevention learned that the driver's license the suspect had presented was fraudulent. The actual credit card holder was contacted in New York. She stated she had received a Sears credit card in the mail a week ago and didn't know why as she had not applied for the card. The suspect admitted that she did not have permission to use the credit card and that an acquaintance had given her the card and the fake driver's license and told her what to buy. The 25-year-old female from Yonkers, New York, was arrested and charged with "Fraudulent Use of a **Financial Transaction Device.**"

The Troy Police Department will continue to participate in the Operation Medicine Cabinet prescription drug take back program throughout the year. Citizens can bring unwanted prescription drugs to the Police lobby 7am to 10pm Monday through Friday and 8am to 4pm on Saturday for disposal. (No medical offices or commercial disposal allowed for Operation Medicine Cabinet) Only dry pills will be accepted, no liquids, sharps or packaging material.

She stated that since January of 2012 she has wired between \$45,000 and \$60,000 to various persons. She stated that she had been promised millions of dollars in winnings if she agreed to pay legal and processing fees up front. The officer explained to the woman that she was the victim of a scam.

Domestic / Family Trouble

Troy Officers responded to eight incidents involving domestic disputes or family troubles during this reporting period. On-scene investigation of these incidents did not result in evidence of crimes being committed; however, Officers were required to take non-enforcement actions to either mediate the situation or keep the peace. Readers should be aware that although these incidents did not result in arrest or prosecution, they do represent significant law enforcement resources in terms of time, on-scene investigation, potential relocation of disputants, referrals to support agencies, peace keeping, as well as detective and prosecutorial review.

Troy Police Department Pistol Team Wins Governor's Cup - "10 years in a Row"

On September 12, the Troy Police Department Pistol

Team won the Class A competition at the annual Michigan Police Shoot in Jackson. The team was awarded the Governor's Cup for Class A, which includes police departments with 100-499 employees.

The annual event is sponsored by the Michigan Association of Chiefs of police (MACP). The tradition dates back to its inception in 1928 which began at the Michigan State Police Headquarters in East Lansing. The purpose of this event is to encourage marksmanship by Michigan peace officers. The Governor's trophies have been awarded in each of "4" classes since 1949.

The 2012 Troy Pistol Team consisting of Sgt Robert Wolfe, Sgt Joseph Haddad, and Officers Craig Fitzpatrick, Milt Stansbury, and Patrick McWilliams won the match with a score of 1251 out of 1500, with 15 shots placed at the center "X" of the bulls eye.

Online Police Reporting Now Available in Troy

The Troy Police Department has implemented an online police incident reporting system. A significant goal in this effort is to enhance our overall

level of service by providing citizens the option and ability to file some of the more routine types of police reports conveniently online. Another goal is to optimize available time for police officers on patrol to more quickly respond to priority calls for service, detect and arrest individuals committing crimes, address traffic problems, and engage in other problem solving activities that enhance public safety. Often calls that are of a minor nature or are simply a request for a routine police report will find citizens waiting for what can be extended periods of time for a patrol officer to arrive due to the need to prioritize responses to more serious calls for service. Requiring citizens to come to the police department in person to file these types of reports can also result in the inconvenience of waiting in long lines. In the face of fewer officers on patrol, it is anticipated that the effective use of this system could potentially reduce overall response time associated with more serious incidents, as well as increase available time for officers on patrol to engage in proactive police work.

Generally, routine incidents and minor crimes cannot be assigned for investigation due to the need to use investigative resources for more serious offenses. Banks, insurance companies, and cell phone carriers still require a police report to respond to identity thefts, process claims, or intervene in situations of harassment involving cell phone technology. This system will provide citizens with that resource conveniently and online.

- Through computer terminals located in the Troy Police Department lobby
- Through the City of Troy / Police Department website home page
- Through the City of Troy Police Department's Facebook page

City of Troy Remains the Safest City in Michigan

On December 8, 2011, CQ Press released City Crime Rankings 2011-2012: Crime in Metropolitan America. CQ Press uses six crime categories to establish crime rate rankings for all cities with a population of at least 75,000 that report crime data to the FBI. The crime categories include: murder, rape, robbery, aggravated assault, burglary and motor vehicle theft. The rankings in the CQ report are based upon data reported to the FBI for 2010.

According to the CQ report, Troy has the lowest crime rate ranking in Michigan for cities with a population of 75,000 or more. Nationwide, Troy ranked 19th for cities with a population of 75,000 or more. Troy was ranked as the safest city in Michigan 10 of the last 14 ranking periods, including the current one. Troy has achieved "Safest City" rankings as high as 5th and 6th in the United States, in 2006 and 2005, respectively. In fact, in other than 2009, when it ranked 38th overall, Troy has consistently ranked among the top 25 safest cities in the United States with populations over 75,000 since 1998.

The crime categories used by the CQ Press include all FBI Part 1 crimes, except larceny and arson. The FBI defines Part I crimes as the more serious crimes that

occur in a community.

The number of Part 1 crimes reported to the Troy Police Department from 2000 through 2010 are as follows:

Incidents of violent crime, which include murder, rape, robbery and aggravated assault, are extremely low. In 2010, there were only 53 violent crimes reported to the Troy Police Department, which represents less than 3.0% of the total Part 1 crime in Troy.

Murder: 1 Rapes: 10 Robberies: 9

Aggravated Assault: 33

It should be noted that although 10 acts of criminal sexual conduct that occurred in Troy are classified as "rapes" in the FBI statistics, these types of assaults in Troy do not usually involve a victim being attacked by

a stranger. There were no forcible rapes involving a stranger assaulting an unknown victim in 2010. Acts of criminal sexual conduct in Troy generally relate to incidents where one of the actors is a minor, complaints where incest or molestation by family members are alleged, or complaints of non-consensual acts between individuals who are acquainted with one another.

The Troy Police Department responded to a total of 35,018 incidents of all types in 2010. The Troy Dispatch center received approximately 173,000 incoming telephone calls in 2010, of which 40,335 were 911 calls. The department hosted 236 crime prevention and other safety programs in 2010, which were attended by 14,632 citizens. Additional workload statistics for 2010 are noted below:

Arrests: 2,520 (393 drunk driving)

Criminal Cases Investigated: 2173

Traffic Crashes: 3,367

Traffic Citations: 12,164 (8,723 crash

causing hazardous violations)

This "Safest City" ranking represents an ongoing and significant achievement not only for the Troy Police

Department, but for the community in general. It is a tribute to the residents; an excellent school system; strong prevention programs such as those provided by the Troy Community Coalition, Boys and Girls Club, Troy Youth Assistance, and many others; an effective District Court; and an active business community. The current ranking for the lowest crime rate in Michigan, reinforces the high quality of life that is offered in Troy. The Troy Police Department is dedicated to continuing to work with the community we serve, as well as City Management and City Government to assure this city remains a safe and attractive place to live, raise families, work, and recreate.

In commenting on the latest ranking, Troy Police Chief Gary Mayer spoke about the dedication and quality of the employees of the Troy Police Department. He noted the commitment to public safety this community has consistently sought to maintain. He pointed out the significant number of community volunteers that have come forward to act as our eyes and ears in conjunction with the "Citizens on Patrol Program," which was formed in the face of recent staffing cuts. The Chief stated, "The Troy Police Department is made up of professional men and women who work hard to identify and solve problems. They, like so many in our

community, have had to work through some significant challenges in terms of the current economic climate. They have been called upon to make sacrifices, yet they continue to provide this community with a level of law enforcement service that I am convinced is second to none. We have become a smaller, but more streamlined organization. We value the resources we have been provided and are dedicated to utilizing those resources to deliver the best law enforcement service possible."

Oakland County Animal Control Services will responsible for the following:

- Respond to and investigate animal bites on any animal that may carry rabies.
- Respond 24/7 to calls involving animals that put the public at risk.
- Sell, process, and record the licensing of dogs.
- Impoundment, care for, and attempt to reunite stray dogs.
- Annual dog census.
- Investigations of reported animal cruelty.

- Support and administration for shelter operations and enforcement.
- Enforce the Dangerous Dog Act, including any vicious animals.
- Investigate and enforce multiple animal control law violations to include: wolf/dog breeding, ban on large carnivores, dog fighting, and suspected rabies cases.
- Sick and injured animals with the potential of rabies causing hazard to the public.
- Any wild animal in a residence living area, and a public hazard to the community.
- Animals running at large, other than cats.
- Found animals, other than cats which must be dropped off at the county facility.
- Welfare checks on animals left in vehicles. (Cruelty)
- Respond to assist police where animals are involved. (Arrest's, drug raids, etc.)
- Investigate and prosecute Dog Fighting Charges.
- Investigate suspected rabies in domestic and wild animals.
- Inspection and issuance of licenses to Kennels within Oakland County.

Oakland County Animal Control Services will not

respond to the following (and neither will the Troy Police Department):

- Pick up stray and or nuisance cats, provide cat impoundment, or return cat's to owners.
- Noise/barking dog complaints.
- Number of dogs allowed in residence.
- Disturbance of birds and bird nest.
- Permits for domestic livestock or dangerous animals.
- Coyote complaints (DNR matter)
- Geese problems (DNR matter)
- Pick up injured wildlife and transport to wildlife or sanctuary.
- Annually inspect kennel facilities, unless claim of cruelty.
- Pet shop inspections, unless cruelty.
- Tethering, unless claim of cruelty.
- Feeding waterfowl.
- Hunting and trapping of animal violations, unless cruelty.
- Delivery of rabies specimens to Lansing for testing.
- Provide shelter quarantine of attack animals.
- Euthanasia of sick or ill-tempered animals for residents.

 All animal give-ups must be taken to the county facility. (costs incurred by resident) Picking up of dead animal carcasses on roadway. 	
Troy DPW will pick up dead animals on the roadways. Dead animals on Private Property will be the private property owner's responsibility.	
The Troy Police Department will respond to emergency calls concerning dangerous animals, such as a dog attacking a person.
