## **Operating a Motor Vehicle While Intoxicated**

**Northbound Crooks Road, South of W. Big Beaver Road, 3/26/2016, 1:49 AM:** Officer initiated a traffic stop on a black 2009 Ford Focus that was being driven erratically. The officer spoke with the driver, a 27 year old male out of Farmington Hills, and noted an odor of alcohol emanating from inside the vehicle. The driver admitted to having consumed three alcoholic drinks earlier at a bar. The driver was asked to perform several sobriety evaluations to which he did but the officer noted that he performed poorly. He submitted to a Preliminary Breath Test with a result of .13%. He was arrested and charged with Operating a Motor Vehicle While Under the Influence of Alcohol – 2<sup>nd</sup> Offense. **16-9247** 

#### **Drugs/Narcotics of Interest:**

Northbound Interstate 75, West of Adams Road, 3/25/2016, 11:35 PM: Officer initiated a traffic stop on a silver 2005 Jeep Liberty that was being driven erratically. The officer spoke with the driver, a 23 year old male out of Pontiac, and noted an odor of alcohol emanating from inside the vehicle. The officer could also see an open container of alcohol between the driver's feet. The driver admitted to having consumed one alcoholic beverage several hours prior to being stopped and admits to using marijuana, Ativan, and heroin on a regular basis. The driver was asked to perform several sobriety evaluations to which he did but the officer noted that he performed poorly. He submitted to a Preliminary Breath Test with a result of .081%. He was arrested and while his vehicle was being searched, a possible crack pipe and rolling papers were located in the center console. He was transported to the lock-up facility where he agreed to submit to a Blood Test. He was charged with Reckless Driving, Transporting an Open Container of Liquor in a Motor Vehicle, Narcotic Ordinance Violation, and Operating a Motor Vehicle While Under the Influence of Narcotics pending Laboratory Results. 16-9229

Hawthorne Suites, 2600 Livernois Avenue, 3/26/2016, 1:34 AM: Officers responded to the business on report of loud party complaint. Officers located a black 2010 Ford Fusion parked nearby that contained four occupants and the vehicle engine was running. Officers spoke with the occupants and noted an odor of marijuana emanating from inside the vehicle. When asked, the occupants stated they had smoked marijuana earlier but there was nothing illegal in the vehicle. The subjects were asked to step out of the vehicle to which they complied. Found inside the purse of a 23 year old female from Detroit was plastic bag which contained suspected marijuana. The substance in the bag was field tested with a narcotics test kit with the officers receiving a positive reaction for the presence of marijuana. A further inspection of the vehicle revealed two plastic cups in the center console that contained a frozen drink that had an odor of alcohol. Three of the occupants were under the age of 21 and agreed to take a Preliminary Breath Test. One of the subjects, a 20 year old from Detroit, had a Preliminary Breath Test result of .053% while the other two subjects had results of .000%. The 20 year old subject was issued a misdemeanor citation for Consumption of Alcohol While Under the Age of 21. The 23 year old suspect was arrested and charged with Possession of Marijuana. 16-9245

Northbound Rochester Road, North of E. Big Beaver Road, 3/27/2016, 12:31 AM: Officer initiated a traffic stop on a blue 2002 Pontiac Montana for a traffic violation. The officer spoke with the driver, a 54 year old male out of Rochester, and determined that his Operator's License was currently 'Suspended' by the Michigan Secretary of State. He was arrested and while being searched, the officer located a plastic bag in his right shirt pocket which contained narcotics identified as Oxycontin. He was charged with Driving While License Suspended and Possession of Synthetic Narcotics. 16-9364

Hawthorne Suites, 2600 Livernois Avenue, 3/27/2016, 2:49 AM: Officer located a suspicious gold 2007 Saturn Aura parked in the parking lot with the engine running. The officer approached the vehicle and noted it to be occupied by a 21 year old male out of Detroit. The officer observed an open container of alcohol sitting near the gear shifter. The subject was unable to provide any identification to the officer and provided a different name and multiple dates of birth as to who he was. The officer was able to able to determine his true identity and arrested him, charging him with Hindering and Obstructing a Police Officer and Transporting an Open Container of Alcohol in a Motor Vehicle. 16-9373

The narcotic was determined to be Alprazolam and the subject admitted to having ingested the other half a couple of hours earlier. The victim turned around to speak with the subject and an argument ensued. The subject asked the victim to step outside to settle this and the victim obliged. When the victim got outside, the subject went to his late 90's Dodge Caravan and retrieved a knife, holding it in his right hand. The victim told the subject to put the knife away and they'd still fight. The subject got into his car and eventually left, not before circling the parking lot three times. He was described as being in his mid 30's, 6'0" tall, approximately 220 LBS with a heavy build. The victim went inside the business to finish his meal when he realized he was missing his Apple IPhone 6. He believes he left it on the restaurant countertop prior to walking outside the building. He believes some youths behind him in line may be responsible for the theft. 16-9102

All the purchases were completed in the Toledo, Ohio area. The victim did not give anyone permission to do such and does not know how her personal information was compromised. **16-9188** 

Benihana's Restaurant, 1985 W. Big Beaver Road, 3/25/2016, 9:43 HRS: Employee was completing a carry-out transaction and noticed the credit card numbers swiped did not match the numbers that appeared on the receipt. The suspect left with his \$20 food purchase but returned to complete another carry-out purchase. The employee stalled in completing the order and the responding officers were able to arrive while the suspect was still at the location. It was determined that the credit card was fraudulent and the suspect, a 23 year old male out of Southfield was arrested. Several other fraudulent credit cards were found in the center console of the suspect's vehicle. He was charged with Possession of a Forged Object and Illegal Use of a Credit Card. 16-9212

# **Domestic/Family Trouble:**

Troy Officers responded to eight incidents involving domestic disputes or a family troubles during this reporting period. On-scene investigation produced enough evidence that two crimes of Domestic Assault were committed and two arrests were made. However, officers were required to take non-enforcement actions to either mediate the situations or keep the peace with the remaining domestic disputes. Readers should be aware that although some of the incidents did not result in arrest or prosecution, it does represent significant law enforcement resources in terms of time, on-scene investigation, re location of disputants, referrals to support agencies, peace keeping, as well as detective and prosecutorial review.
