**GARAGE SALE RULES AND REGULATIONS AS FOLLOWS:**

**4-02-01-020 Regulations**

- (1) No such sale shall be conducted for more than three (3) consecutive days nor more often than four (4) times in any one-year period. (Ord No. 421, 10-31-2012)
- (2) No items offered for sale shall be displayed within the village street or sidewalk right-of-way or in such a manner as to obstruct the normal flow of vehicles or pedestrian traffic.
- (3) All signs pertaining to garage sales must comply with section 6-03-070(c)(11) of the Holly Village Code. (Ord. No. 150, 11-12-1985)

**4-02-01-030 Permit required**

- (1) It shall be unlawful for any person, owner, tenant or lessee of a residence to conduct, advertise or promote a garage sale without first obtaining from the Holly police department a permit to do so. The request for application for a permit shall include the following information:
  - (a) The names and address of the persons conducting the sale and the residence where the sale will take place, if different.
  - (b) The date the sale will commence and end and the date of any prior sale at the same residence.
  - (c) A general description of the items to be offered for sale.
  - (d) An affirmation that the items to be sold are the sole property of the applicant and were not purchased for the purpose of resale.
- (2) There shall be no charge for the sale permit; however, no more than one permit shall be issued for any one residence within any calendar quarter.
- (3) The permit or permit number shall be displayed in a front window at the sale location. (Ord. No. 150, 11-12-1985)

**4-02-01-040 Exemptions**

- (1) This article shall not apply to legitimate moving or estate sales conducted in accordance with the sale of a residence or a judicially sanctioned estate or probate sale.
- (2) This article shall not apply to sales by persons selling three (3) items or less of tangible personal property or goods, which they own and which is not displayed for sale.
- (3) This article shall not prohibit sales authorized by other ordinances of the village. (Ord. No. 150, 11-12-1985)

**4-02-01-050 Violations, Penalty or Sanction**

[The initial fine shall be \$50.00. A second offense within one (1) year of the date of the initial infraction shall result in a \$100.00 fine. Third offense will result in a \$250.00 fine. Fourth and subsequent offenses shall result in a \$500.00 fine.]
