Lakes Area Bait Shop Waiver and Release of Liability

1. This waiver and release is intended to and does release Lakes Area Bait Shop from any and all liability for damages or injuries on account of or in any way related to or growing out of my negligence, the negligence of third parties and Lakes Area Bait Shop's negligence. This is not intended to release Lakes Area Bait Shop from any liability resulting from their intentional conduct.

I further covenant and agree not to institute any claims or legal action against Lakes Area Bait Shop for any claim released by this Agreement. I further agree that should any claim be made against Lakes Area Bait Shop in contravention of this Agreement, including but not limited to derivative claims, I will protect, defend and completely indemnify (reimburse) Lakes Area Bait Shop for any such claim and expenses including attorney's fees and costs incurred by Lakes Area Bait Shop in defending themselves or security indemnity hereunder.

2. I understand that Lakes Area Bait Shop is not responsible for any lost, stolen, or damaged valuables or property.

3. I acknowledge that I have received and read a copy of the current rules and regulations governing the use of the facility. I agree that I will fully comply with all rules and regulations and with any amendments.

I have read the Agreement and understand that by signing the Agreement I have consented to be bound by its terms, including the waiver/release of any legal right I may have to sue Lakes Area Bait Shop for any costs they incur because a claim or legal action is brought in violation of this Agreement. I agree any violation of the Agreement and its terms and conditions, as determined by Lakes Area Bait Shop, will void and terminate this Agreement and may result in loss of the ability to use the facility.
