The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Assault in the 1st Degree (Peace Officer, Prosecutor, Judge or Correctional Employee)**

Minnesota Statute: 609.221.2, with reference to: 609.221.5(a)(1), 609.221.5(b), 609.11.5

Maximum Sentence: 10-20 Years and/or \$9,000.00 - \$30,000.00

Offense Level: Felony

Offense Date (on or about): 10/04/2021

Control #(ICR#): 21225114

Charge Description: On or about October 4, 2021, in the County of Anoka, Minnesota, RANDALL WILLIAM REEVE, did assault a peace officer by using or attempting to use deadly force against the officer while the person was engaged in the performance of a duty imposed by law, policy, or rule and at the time of offense, the Defendant did use or possess a firearm.

**COUNT II**

**Charge: Threats of Violence**

Minnesota Statute: 609.713.1

Maximum Sentence: 0-5 Years and/or \$3,000.00 - \$10,000.00

Offense Level: Felony

Offense Date (on or about): 10/04/2021

Control #(ICR#): 21225114

Charge Description: On or about October 4, 2021, in the County of Anoka, Minnesota, RANDALL WILLIAM REEVE, did threaten, directly or indirectly, to commit any crime of violence with purpose to terrorize another, namely DVF, or in a reckless disregard of the risk of causing such terror.

**COUNT III**

**Charge: Reckless Discharge of a Firearm Within a Municipality**

Minnesota Statute: 609.66.1a(a)(3), with reference to: 609.66.1a(b)(2)

Maximum Sentence: 0-2 Years and/or \$1,500.00 - \$5,000.00

Offense Level: Felony

Offense Date (on or about): 10/04/2021

Charge Description: On or about October 4, 2021, in the County of Anoka, Minnesota, RANDALL WILLIAM REEVE, did recklessly discharge a firearm within a municipality.

## STATEMENT OF PROBABLE CAUSE

At approximately 10:14 PM on October 4, 2021, officers from the Blaine Police Department responded to a report of a male who was threatening others and firing a gun in the area of 10562 Quincy Blvd NE, in the City of Blaine, within Anoka County.

Upon arrival, officers spoke with a resident of the area, DVF (an adult female, fully identified in the reports). DVF advised officers that a male, later identified as RANDALL WILLIAM REEVE (DOB 8-21-1959), the defendant, had confronted her and her boyfriend while holding and racking a shotgun. DVF also reported that after racking the gun, she and her boyfriend went inside, but could hear the defendant firing the gun outside.

Officers then set up a perimeter outside the defendant's residence at the above address. For several minutes, the defendant repeatedly opened the door, yelled obscenities at the officers as well as threats to kill them, and fired the gun both into the air and in the direction of the officers. The defendant appeared to be shooting both a shotgun and a rifle. Officers later located a bullet hole in one of the squad cars parked nearby.

After several minutes, officers confronted the defendant, who sustained a gunshot wound. The defendant is currently hospitalized, but is expected to recover. A warrant is being requested to secure his appearance in Anoka County District Court upon his release to establish appropriate release conditions.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

Complainant declares under penalty of perjury that everything stated in this document is true and correct. Minn. Stat. § 358.116; Minn. R. Crim. P. 2.01, subds. 1, 2.
