Dear U.S. Attorney General Bondi:

This is a follow up letter, to the original letter we sent to interim attorney general dated January 31st, 2025. We are requesting your immediate federal assistance in the State of Minnesota.

Civil rights of at least 21 Minnesotans have been violated when their legally cast ballots were destroyed prior to their votes being counted. Regardless of the outcome of an election, American citizens have the right to know when they cast a vote, the very foundation of our democratic process, that their vote will be accurately counted. The survival of our democracy relies on the continued faith of the citizens trusting elections are fair and the candidate that is declared the winner is the candidate who received the most validly cast votes.

Our state being completely controlled by the Democrat party, legislative, judicial and executive branches - we are now at a crucial breaking point.

Specifically, where we are asking you to focus your attention is on our election system. Due to us being completely trapped in a Democrat machine, you have an incredible opportunity to audit and expose election irregularities and help bring complete transparency to rebuild public confidence in our election process once again.

MN House District 54A had serious and multiple election problems and inconsistencies, which any of the following could change the outcome of who was rightfully elected to this House seat:

- Election results pulled and all results zeroed out after publicly displaying 100% precincts reported and the GOP House Candidate, Aaron Paul was shown to have won by 360 votes.

- Later at approximately 3 am the numbers were dumped back in and showed the Democrat incumbent, Brad Tabke winning by 14 votes.
- **Nov. 27th, Scott County MN Elections Manager – press release admitted that 21 ballots were destroyed. Breaking Federal Law 52 USC 20701.**
- Court trial: Dec 16th – 17th, Scott County judge on Jan. 14th, ruled there was not enough proof that the 21 destroyed votes would overturn the election.
- MN has a late County voter data submission deadline of Dec 17th, this is *past* the date a candidate is able to legally contest an election. Therefore, the following information found in the Scott County data was NOT included in the Dec. 16th – 17th trial:
 - 30 voters with duplicate vote records (voted two times each) in the official OSS data.
 - 96 more cast vote records than voter histories (number of people who voted).
- Scott County, MN – delayed official data requests and the official OSS data continued to be changed weekly after the Dec. 17th deadline, which is proven and we have preserved with weekly data requests that we obtained directly from the OSS.

Please consider the urgency needed in calling for a full federal investigation and forensic audit to validate election results and protect the civil rights of voters in Minnesota's House District 54A.

Your investigation truly would be a turning point and landmark moment to help Minnesotans regain their trust in our election system.
