Facilitated Conversation Panelists



Sarah Greenman is an Associate Professor of Criminology and Criminal Justice at Hamline University. She does research in the areas of sanctioning and deterrence, violence and victimization, and community based crime prevention focusing on a variety of crime types from intimate partner violence to pyramid scheme victimization. In addition to conducting research, she regularly teaches courses on Victimology, Theories of Criminal Behavior, and Courts and Sentencing.



Christopher Nguyen is the Founder and Principal at Aberrant Law PLLC. He is the chair of the Ramsey County Corrections advisory board, a council member for the Minnesota State Bar Association's criminal law section, and a member of the Minnesota Association of Criminal Defense Lawyers. Nguyen is also an Officer in the United States Army and Minnesota Army National Guard, serving as a Judge Advocate and as a member of the Judge Advocate General Corps. He has been married to the love of his life, with whom he shares share 6 children, for nearly 25 years.



Bruce Peterson was a District Court Judge from 1999 until his retirement in May, 2019, sitting in Hennepin County, Minnesota. From 2006 to 2008 he was the presiding judge of Hennepin County Family Court. From 2008 to 2013 he initiated and presided over Co-Parent Court, offering supportive co-parenting services to low income, unmarried parents establishing paternity. From 2013 to 2016 he presided over the Hennepin County Drug Court and specialized calendars for people who are homeless and women charged with prostitution.

Judge Peterson was a 1978 graduate of Yale Law School, a special assistant in the Criminal Division of the Department of Justice, an Assistant United States Attorney for the District of Columbia, and a partner in the Minneapolis law firm of Popham, Haik, Schnobrich and Kaufman. He was the 2013 recipient of the Hennepin County Bar Association Professionalism Award and many other recognitions. He has been an adjunct professor at the University of Minnesota Law School since 2003. He has written and spoken widely on issues of law and public policy.
