Re: WARN Act Notice Notification

Dear WARN Act Coordinator:

Pursuant to the federal Worker Adjustment and Retraining Notification (“WARN”) Act, Oracle America, Inc. (“Oracle”) hereby provides notice that it will be terminating employees at CoxHealth (“Client”) located at 1115 E. Primrose Street, Springfield, Missouri (“Springfield Client Location”). Client is transitioning the health information technology operations that have been provided by Oracle back to the Client. The Springfield Client Location is not shutting down, but Oracle’s ITWorks operations at the Springfield Client Location are shutting down as part of this reduction in force. It is anticipated that these layoffs will be permanent. No bumping rights exist as part of this cessation of operations.

Oracle is individually notifying all affected employees as on February 1, 2024. Affected employees will be separated from their positions as of April 1, 2024. It is our understanding that the Client has already made offers of employment to all of the affected employees.

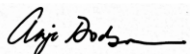
