**Dear WARN Coordinator:** 

On behalf of Royal Canin North America ("Royal Canin"), this notice is being provided to you pursuant to the Worker Adjustment and Retraining Notification Act of 1988 which requires employers to give official notice to certain government units or officials of a pending office and/or plant closure.

Royal Canin (EIN 221594774) is permanently closing its plant located in Rolla, Missouri, at the following address:

Royal Canin 1700 Bridge School Road Rolla, MO 65401

Manufacturing is being transferred to other Royal Canin facilities.

It is currently anticipated that this final closing will take place following decommissioning on December 31, 2025. Production is expected to end on April 18, 2025.

All 105 associates can seek alternate employment within Royal Canin and the Mars, Incorporated ("Mars") family of companies. Associates who have not secured alternate employment within Royal Canin or Mars will be separated from employment because of the plant closing. As of the date of this letter, it is anticipated that 85 associates will separate from employment on April 18, 2025, and the remaining 20 associates will separate on December 31, 2025.

Associates will receive notice of their last day of employment/date of separation no later than 60 days before the effective date.

A list of the affected positions and the number of associates holding each position is enclosed herewith. Affected associates are not represented by a union and do not have bumping rights.

Affected associates were first notified of the closing on January 14, 2025.
