RE: Worker Adjustment and Retraining Notification Act ("WARN")

To Whom it May Concern:

The undersigned is Director of Human Resource for Penske Logistics LLC ("Penske"). This letter constitutes written notice to you pursuant to the notice requirements of the WARN Act.

Penske has performed warehousing services for Schnucks's at the facility located at 8500 Scudder Avenue, Kinloch, MO 63140. Effective July 15, 2025, operation of the facility will be transitioned to the new logistics provider.

At present, Penske Logistics employs approximately 337 individuals at this location. Effective July 15, 2025, Penske will transition the operations at the 28500 Scudder Avenue, Kinloch, MO 63140 location to BGDC Distribution. As a result, individuals identified on the attached Exhibit A will be permanently laid off by Penske; however, we understand there will be opportunities for continued employment with BGDC Distribution. BGDC Distribution and Penske will work together to communicate a transition plan and direction on applying for employment with BGDC Distribution.

Penske does not have a job bumping system, that is, employees will not be able to displace more junior employees out of their job positions as a result of this contract transition.

Penske has been honored to provide service at this facility on behalf of Schnucks and will work diligently to ensure a smooth transition of the operation to BGDC Distribution as it takes over operation of the facility.
