To Local Government Officials:

This letter is to inform you that Main Street Sports Group, LLC (the “Company”) will conduct employee separations in connection with the closing of its facility located at 6 Cardinal Way, St. Louis, MO 63102. The entire facility will close, including remote workers. This action is expected to be permanent. While we do not meet the threshold to trigger WARN, we wanted to make you aware of our Company’s circumstances.

The first employee separations as a result of this action will occur during the 14-day period beginning on April 14, 2026. Enclosed is a listing of the job titles of the positions to be affected, the number of affected employees in each job classification, and the affected employees’ anticipated separation dates.

There are no bumping rights for the affected employees.

The affected employees are not represented by a union.
