



Missouri Cannabis Regulation Collaborative (MCRC)

Application Selection Process

Who can apply?	Any owner, operator, compliance manager or other leadership-level representative of a licensed <u>operating</u> facility within the vacant categories listed below. Microbusiness licensees must be working towards becoming operational. To help support clear communication, DCR will require acknowledgment from the Designated Contact that the applicant may represent the licensee on their behalf. NOTE: Members who completed the 2024 two-year term are not eligible to apply. However, an individual from the same organization may apply. Other considerations: • Only one representative from a license may apply. • Only one representative from a group of licensees linked through common ownership or under common management may apply. • In case of member openings on MCRC, DCR may hold a new application period for new members to complete an existing term.													
What is the time commitment for members?	• In-person quarterly meetings (Approximately 4 hours) • There may be some work between meetings and/or voluntary subgroup meetings for specific topics. • In-person meetings will be in Jefferson City. • 2-year term (January 2027 – January 2029)													
How will you select members?	DCR wants to ensure a diverse workgroup comprising a range of business structures, including small and large facilities, multiple license holders, stand-alone operators, and individuals with diverse backgrounds and expertise. The collaborative will have representation from all license types and regions across the state, with no more than 30 members. Applications will be selected by a committee comprised of the DCR Public Outreach Director, a representative from the Office of Operational Support, and three individuals from another DHSS division with experience in reviewing applications.
