## THE TRUMP ADMINISTRATION HAS ACCOMPLISHED THE FOLLOWING TO PREVENT CRIME & IMPROVE REENTRY

- Signed the First Step Act of 2018, including reauthorization of the Second Chance Act, to enact reforms to bring about a fairer U.S. justice system and help inmates reenter society successfully.
- Launched the Federal Interagency Council on Crime Prevention and Improving Reentry, which comprises the White House and 11 federal agencies, to "provide those who have engaged in criminal activity with greater opportunities to lead productive lives."
- Created the Commission on Law Enforcement and the Administration of Justice to explore issues that most impact the reduction of crime, including a focus on social issues and reentry.

## **AND TO REVITALIZE COMMUNITIES**

- Established Opportunity Zones, through the 2017 Tax Cuts and Jobs Act, to bring economic growth and jobs to low-income communities by incentivizing long-term investments.
- Created the White House Opportunity and Revitalization Council to help coordinate Opportunity Zones and other strategies in distressed communities plagued by high poverty levels, failing schools and scarce jobs.

## **HOW TO START**

The Reentry Resource Center is a one-stop shop on recent news, topics and resources related to crime prevention and reentry. It enables anyone to browse for information and available federal funding. Here are examples of available opportunities:

- The Second Chance Act, which supports funding through the Justice Department's Office of Justice Programs, such as reentry services for youth previously involved in gangs.
- Second Chance Pell, which supports Department of Education programs to provide education opportunities for incarcerated students.
- Department of Labor's Federal Bonding Program and other funding to support employment.
- Justice Department's CrimeSolutions.gov, a clearinghouse that assesses whether programs achieve their goals.
- Department of Housing and Urban Development's strategies to revitalize communities through tax incentives and investments in housing in distressed areas.
- Department of Agriculture's investments in infrastructure and economic development in rural areas.
- Department of Health and Human Services programs to help communities prevent and address physical and mental health, and gaps in treatment for substance use.
