### **Positive Outcome**

Sgt. Dubuc was contacted by a recent burglary victim who discovered his stolen items were listed for sale on Facebook Marketplace. Sgt. Dubuc worked with Sgt. Stanton of P4/P2 CRT to identify and locate the suspect. A search warrant was executed, and the victim's stolen items were recovered, along with items taken in other burglaries. Sgt. Dubuc interviewed the suspect and was able to get a confession. The suspect was subsequently booked for PC Burglary. Due the efforts of Sgt. Dubuc and Sgt. Stanton's team, the 2<sup>nd</sup> Precinct will likely see a notable decrease in burglaries.







### **Positive Contact**

2<sup>nd</sup> Precinct Officer of the Year Melinda Carlson responded to a welfare check call of a person in a wheelchair stuck outside as inclement weather was approaching. Since there was going to be a delay in the arrival of a transport van to take the woman back to her care facility, Officer Carlson wheeled the woman to the 2<sup>nd</sup> Precinct station where she could safely and comfortably wait in the lobby for her transport van.



### **Positive Outcome**

Officers were dispatched to a burglary in progress at an apartment building where a door had been forced open and the locks were broken. Upon arrival officers found two persons still inside the apartment. Although one of the parties claimed that he used to live in the apartment both were identified. Checks showed that one of them had warrants for his arrest and that he was also a prohibited person who cannot have a firearm or ammunition. There was live ammo on the table next to a bag that contained a handgun as well as the suspects identification. Suspected narcotics were also found inside the bag. Ironically one of his warrants was for being a felon in possession of a handgun. The male was placed under arrest for PC Weapons and was booked at HCJ. Officer Werner conducted an incustody interview and got the male to admit that the handgun was his. Charges were submitted to the HCAO for felon in possession of a firearm.

Officers secured the firearm and secured the two occupants. Officers also located a large amount of Fentanyl on one of the occupants of the vehicle. Officers arrested one of the occupants for Probable Cause Narcotics and Weapons. The suspect was charged for Aggravated controlled substance 1st Degree and Illegal Possession of a Firearm. Great job by officers being vigilant and taking these narcotics and firearm off the street.



### **Positive Outcome**

In November of 2022, Minneapolis Police Officers responded to an explosion that was detonated outside of a hair salon in the Bryn Mawr Neighborhood. About a year later, police responded to a second damage to property call at the same hair salon, where the suspect in that case threw a retaining wall brick through the front window of the business. Officer Humphrey was assigned the case and worked on it. Through the review of surveillance footage and forensic evidence, and the assistance of agents from the FBI, he was able to determine that the suspect was the same for both incidents. Further, Officer Humphrey was able to identify a suspect in the incidents. In March 2024, Officer Humphrey and agents from the FBI executed a search warrant at the suspect's residence. During the search warrant, Officer Humphrey and FBI agents recovered the jacket that the suspect was wearing during the November 2023 damage to property incident; multiple explosive components including suspected energetic powders and fuses; a .32 caliber Iver Johnson Cadet revolver, with ammunition; and methamphetamine. Following the investigation, the US Attorney's Office indicted Michael Allen Francisco with one count of maliciously damaging a building engaged in interstate commerce by means of an explosive device. Currently Francisco is awaiting his federal detention hearing. Excellent investigative work conducted by Officer Humphrey.





### **Positive Contact**

Officer Bartholomew was flagged down regarding a violent unwant that was in a vacant apartment who had no standing in the building. Officers made contact with the male who was obviously under the influence or narcotics as well as suffering from mental health. The male was also making numerous threats that he was not leaving without a fight. Officer Bartholomew remained calm and was very patient with the male as well as the assisting Officers who took turns speaking with the male. More resources were called due to the aggravated condition the male was in. BCR arrived and attempted to get the male to leave. The male's sister was called and asked to come to the scene to help collect the male's belongings and help coax the male into leaving the property. After an hour standstill, Officer Bartholomew and the male's sister were able to talk him into leaving. Officer Bartholomew and the male's sister walked him to her car and she took him home to 5100 Colfax Ave N. A caution note was placed on the address of 5100 Colfax Ave N regarding the male and his drug use, mental health, and violence towards the Police. The apartment building management thanked the Officers on scene for their excellent work. The sister also called and said thank you for the patience Officers showed her brother during his episode.







## **Detection & Prevention**

- Check for bulges on the machine
  - O Does the reader seem out of alignment?
  - Does it look like the machine is covering another part of the machine?
- Machine may feel like it is coming apart
- Compare it to other machines
- Check your accounts regularly for suspicious activity


Shot Spotter detects gunfire and this is often times used in investigations to determine types of guns, number of shots, and locations.


The glove from the scene was swabbed and tested and it was found to have a known profile. The name and DOB was given to Investigators once it is vetted by Scientists.





### LPR


LPR data showed that a vehicle that registered to the same person as the DNA hit was not only in the area but parked near the scene.

#### Public awareness and quick police action resulted in the arrest of 3 juveniles for aggravated robbery.

April 1, 2024 (Minneapolis) On Sunday night, in the span of one hour, the collaborative efforts of observant 911 callers, MPD officers, the Minnesota State Patrol Helicopter, and other law enforcement partners limited a robbery spree to two incidents and resulted in the arrest of 3 juveniles.

Beginning at approximately 6:45 p.m., on Sunday, March 31st, 2024, a 911 caller reported 7 juveniles in 3 vehicles trying to steal a car from a parking lot on the 500 block of W Lake St. The vehicles involved were described as a red Hyundai, a white Kia, and a silver sedan. About 10 minutes later, a 911 caller reported these three vehicles driving erratically but in formation through the neighborhood near the 3400 block of Holmes Ave. Minutes later, an attempted carjacking and robbery involving the three vehicles and juveniles occurred on the 3400 block of Humboldt Ave S. About two minutes later, another 911 caller reported the same three vehicles chasing each other down 34th St W.

MPD enacted the Robbery Pattern Response Protocol.

At approximately 7:38 p.m., the three vehicles were reported to be parked together in a parking lot on the 4400 Block of Lyndale Ave N and a group of juveniles were sitting in and gathered around them. One of the juveniles was reported to be hanging out of the white Kia waving a gun. Within 2 minutes, a K9 officer arrived at the parking lot and attempted to conduct a suspicious vehicle stop. All three vehicles fled from the officer. The officer focused on the white Kia with the reported gunman and pursued it through North Minneapolis. With the help of a Minnesota State Patrol Helicopter, the vehicle was pursued to an alley near 35th Ave N and Knox Ave N where three juveniles fled on foot. All three juveniles were located, arrested, and booked into the Hennepin County Juvenile Detention Center for Aggravated Robbery. One of the juveniles was 15 years old and two were 16 years old. The Kia was a reported stolen vehicle.

The events of Sunday night are a clear example of what can be accomplished when law enforcement and the community work together to ensure safety throughout the city. "I want to express my appreciation to members of the community who were observant and reported


