The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about May 19, 2024, at approximatley 9:20 p.m., officers responded to a shooting in the 2900 block alley of 18th Avenue South in Minneapolis, Hennepin County, Minnesota. There, officers encountered five victims. Victim 1, a known adult female, had been shot while seated in the backseat of her vehicle. Victim 1 had been holding Victim 2, her two-year old son, who was also hit by gunfire. Victim 1's other two children, Victims 3 and 4, were in the backseat but not hit. Victim 1 later died from her injuries. Despite being shot in the face, Victim 2 survived.

Officers obtained surveillance video from the alley. It shows that the victims' vehicle parked in the alley behind a home. A known adult male, Victim 5, who is the father of the three children in the car, gets out of the driver's side of the vehicle. Investigators later learned Victim 5 was there to borrow tools from his brother. While Victim 5 is out of the car, another car pulls up behind Victim 5's vehicle.

A man, later identified as Defendant AYALE ABDULLAHI ALI (01/01/2004), gets out of the passenger side of the second vehicle and slowly walks up to the victims' vehicle holding a gun. Defendant then fires multiple shots into the vehicle. After a few seconds, Victim 5 returns to the car, sees his wife and child have been shot, and starts screaming. At that point, Defendant shoots at Victim 5, but does not hit him.

Officers recovered seven 9mm discharged cartridge cases from the scene and the crime lab later determined they were all fired from the same firearm.

Investigators learned from multiple witnesses that Defendant might be the shooter. After obtaining search warrants for Defendant's social media accounts, investigators obtained numerous pictures of Defendant holding guns. They also found messages in which Defendant is trying to trade firearms 24 hours after the murder. Investigators learned Defendant's current phone number and obtained its cell site location data. Defendant's phone was at the scene of the murder when it occurred.

After investigators learned this information, they presented witnesses with photo lineups containing Defendant's picture. At least two witnesses identified Defendant. Additionally, investigators obtained a selfie of Defendant at a gas station taken a few hours before the shooting. In the photo, Defendant appears to be wearing the same shoes as the shooter in the surveillance footage.

Defendant has a history of violence. He is on probation in Scott County for aggravated robbery (70-CR-20-13664) and has faced significant charges in Iowa, including a home invasion / attempted murder. Investigators have recovered communications in which Defendant brags about fleeing to Somalia after some of those charges. As such, he presents a unique public safety and flight risk and your complainant requests \$2,000,000 bail.

The State will seek an aggravated sentence based on this murder occurring in the presence of children.

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
