

Diabetes Program/Funding Opportunities

As a part of our grant funding through the Centers for Disease Control and Prevention (CDC), we have several opportunities to work with healthcare systems, clinics and pharmacies across the state in the development and implementation of diabetes related programs. We have available funding opportunities to work on the implementation of both the National Diabetes Prevention Program (DPP) and Diabetes Self-Management and Education Support, along with opportunities to participate in quality improvement and pharmacy related projects.

DIABETES PREVENTION PROGRAM

New DPP Sites

- Funding Available:
 - \$13,000 for up to 3 sites
- Scope of Work:
 - Develop a plan to implement the National Diabetes Prevention Program in person or via telehealth, including administrative support, provider referrals, marketing and outreach, lifestyle coach staffing and training, participant recruitment, and delivery of the curriculum in underserved areas or to target populations.
- Target Audience:
 - Healthcare Systems/Primary Care Clinics/Local Public Health
- Funding Timeline:
 - October 1, 2020 – September 30, 2021

DPP Recruitment and Retention:

- Funding Available:
 - \$5,000 for up to 5 sites
- Scope of Work:
 - Current DPP sites will receive up to \$5,000 to complete a project aimed at increasing recruitment and retention among an underserved population. Sites will focus on projects aimed at increasing retention within programs, which may include working with CONNECT, social determinants of health, increasing access or addressing specific populations.
- Target Audience:
 - Current DPP Organizations
- Funding Timeline:
 - October 1, 2020 – September 30, 2021

DPP Enrollment:

- Funding Available:
 - \$2,000 for up to 13 sites
- Scope of Work:
 - Current DPP sites will receive up to \$2,000 to complete a project aimed at increasing enrollment. Projects can be focused around addressing social determinants of health, working with a local food bank, WIC or a priority population to increase enrollment.
- Target Audience:
 - Current DPP Organizations
- Funding Timeline:
 - July 1, 2020 – June 30, 2021

DIABETES SELF-MANAGEMENT AND EDUCATION**DSMES recognition/accreditation or Quality Improvement:**

- Funding Available:
 - \$5,000 for up to 5 sites
- Scope of Work:
 - Programs will receive funding to work toward recognition/accreditation for onsite or telehealth services. For those sites who have achieved recognition/accreditation funding can be utilized to work on a quality improvement project focused on increasing enrollment and referrals to DSMES.
- Target Audience:
 - Healthcare Systems/Primary Care Clinics
- Funding Timeline:
 - July 1, 2020 – June 30, 2021

DSMES Telehealth

- Funding Available:
 - \$5,000 for up to 5 sites
- Scope of Work:
 - Programs will receive funding to work toward establishing or expanding telehealth within their DSMES programs.
- Target Audience:
 - Healthcare Systems/Primary Care Clinics
- Funding Timeline:
 - October 1, 2020 – September 30, 2021

QUALITY IMPROVEMENT

Electronic Continuous Quality Improvement (eCQI):

- Funding Available:
 - \$5,000 for 2 or more sites
- Scope of Work:
 - Develop a project focused on utilizing electronic continuous quality improvement (eCQI) to improve workflows for people with diabetes or prediabetes and generate referrals to DPP or DSMES.
- Target Audience:
 - Healthcare Systems/Primary Care Clinics
- Funding Timeline:
 - July 1, 2020 – June 30, 2021

Chronic Kidney Disease:

- Funding Available:
 - \$2,500 for up to 5 sites
- Scope of Work:
 - Sites will identify and work on a CKD related project utilizing eCQI and clinical decision support tools.
- Target Audience:
 - Healthcare Systems/Primary Care Clinics
- Funding Timeline:
 - October 1, 2020 – September 2021

Retinopathy:

- Funding Available:
 - \$5,000 for up to 2 sites
- Scope of Work:
 - Sites will identify and work on a retinopathy related project utilizing eCQI and clinical decision support tools to increase the number of screenings completed. Sites may also be awarded retinopathy cameras based upon need.
- Target Audience:
 - Primary Care Clinics
- Funding Timeline:
 - October 1, 2020 – September 2021

PHARMACY

- Funding Available:
 - \$2,500 for up to 10 sites
- Scope of Work:
 - Develop a project within the pharmacy to promote team-based care for people with diabetes. The focus of the project should be centered around

increasing medication adherence for patients with diabetes or pre-diabetes, providing diabetes education, DSMES accreditation, creating referrals for DSMES and/or DPP, and Screen Test and Refer.

- Target Audience:
 - Community Pharmacies
- Funding Timeline:
 - July 1, 2020 – June 30, 2021
