Re: "SDOH Clinical Training" Funding Opportunity (Aug 2024-Jan 2025)

Dear Healthcare Partner,

1. As part of a grant funded by the Centers for Disease Control and Prevention (CDC), the Montana Department of Public Health and Human Services is announcing a training funding opportunity for health care systems, primary care, and community based organizations who serve individuals with or at risk for diabetes in selected areas of the state. The purpose of the training is to improve knowledge, comfort level and competence addressing issues encountered when administering and responding to SDOH screeners. Even if your clinic does not currently administer an SDOH screener, this training will benefit staff's general understanding of patient needs that could impact care. Additionally, clinics can schedule a learning session with CDPHP bureau staff to discuss options for continued grant work related to addressing patient social needs and work with staff to enhance your community connections and build referral partner networks.

Eligibility

This is a **one-time** sub-award for selected health care systems. primary care clinics and community-based organizations.

Award amount

The funding amount will range from \$500 - \$1,000 depending upon the size of the organization and number of staff to be trained.

- 3-10 employees = \$500
- 10 50 employees = \$750
- 50+ employees = \$1,000

Deadlines

Applications must be received (in-hand) by the Montana Diabetes Program by 5:00 p.m. **Wednesday, JULY 29, 2024.**

The project period will run approximately August 2024 to January <u>2025</u>. We hope you consider applying. Social Determinants of Health (SDOH)/ Health Equity Clinical Training Funding Opportunity

PROJECT BACKGROUND

<u>Project Requirements</u> – Funded clinics must address these action items:

- 1. Train clinic staff over a six-month period who interact with patients in a clinic setting to address topics related to a patient's social determinants of health (i.e., housing, food insecurity, transportation). The purpose of the training is to improve knowledge, comfort level and competence addressing issues encountered when administering and responding to SDOH screeners. Even if your clinic does not currently administer an SDOH screener, this training will benefit staff's general understanding of patient needs that could impact care.
- 2. Trainings will be virtual and can be done at times that accommodate varied schedules. A list of trainings will be made available. Each staff person involved will listen to the SDOH basic/intro webinar, then will choose two other webinars from a list of six. An example of training topics will include: an introduction to terms and concepts, empathic inquiry, implicit bias, and cultural humility. The DPHHS Montana Diabetes -program (MDP) staff will organize the training options. Any new clinic staff who begin during the 6-month project and meet the above-mentioned criteria must be trained.
- 3. Document the employees (name and job title) who complete trainings, which trainings are completed and when (date). Report any employees who leave employment during the six-month period and do not complete training. Report any employees hired during the grant period who will be added to the list of persons receiving training. The MDP staff will provide an Excel tracking spreadsheet where this information can be reported and submitted at the end of the project. Complete a one-page report (template will be provided) that allows for your feedback on the training options, their value, and any suggestions.

OPTIONAL:

*Schedule a learning session with MDP staff to discuss options for continued grant work related to addressing patient social needs which can include: choosing an SDOH screener for clinic usage, implementing a workflow for distributing a screener, creating referral lists and finding community partners to assist with needs, recording and reporting on SDOH notes in your EHR and collecting population health data (age, sex, zip code, payer type, race and ethnicity) to determine if there are racial/gender/insurance coverage disparities in health outcomes.

*Create a list of existing partners/CBOs in your community that could help provide services to address a patient's social needs. During the grant period, work with the CDPHP bureau staff to enhance your community connections and build referral partner networks. Use of Funds:

- The funding provided by through this grant may **NOT** be used to buy food_equipment or pay for direct services.
- The grant funding can be used to offset staff time to complete trainings.

Project Updates:

Program staff will schedule one interim call to check on the progress of trainings. Additionally, staff will be available to work with your clinic to answer questions during the grant period.

Consideration:

This training grant may help clinics position themselves to apply for a longer-term Health Equity project.

Project Deliverables: Participating organizations will be asked to submit the following (we will provide report templates):

- Number of staff who completed necessary training.
- The selected training courses completed by each staff member involved.
